

Sir,

In producing here with 15 (Fifteen) arrested accused persons namely (1) Sk. Istayak (45) S/o Sk. Fazlur Rahaman of vill- Manbazar Muslimpara (2) Jagannath Roy Mahato (30) S/o Rahin Roy Mahato of vill- Daha (3) Laxmikanta Mahato (19) S/o Birinchi Mahato of vill- Metiyala tola Mourangdih (4) Ajay Sen (23) S/o Sibankar Sen of vill- Muchaikuli Manbazar (5) Sk. I beg to state that today (07.08.21), I was directed to find out whether the lock down has been implemented properly at Bank more Manabazar or not. This refers to Manbazar PS GDE No- 285 Dtd.07.08.21. Accordingly, I along with C/1211 Chunaram Hembram HG/1419 Santanu Kr. Dutta had been at Bank more Manbazar and found the above noted persons were moving freely in that public place without wearing Mask. Thus they violated COVID -19 protocol as promulgated by Govt. of West Bengal Vide Order No-753/III – ISS/2M-22/2020 dated 14.07.2021, & further extended order no- 753/IV-ISS/2M- 22/2020 dtd- 29.07.2021 till now 15.08.2021 and desperately to spared infection of deceases dangerous to life.

I arrested them for Disobedience to order duly promulgated by the Govt. of West Bengal as above after maintaining all rules of arrest, Issued memo of arrest. I informed them & their relative regarding the ground of arrest.

All the process was done in between 22:00 hrs to 23:10 hrs. There was every chance of breach of peace and requiring of offence if not arrested. As there was lock down in the town the peoples left the place and did not agreed to come forward to remain present.

After that I left for PS. On arrival at PS, I type this letter of complaint at Manbazar PS computer and submitted before OC Manbazar through duty officer S.I. Mahadeb Rana for taking necessary action as per law.
