Sir,

I beg to state that today (08.08.21), I was directed to find out whether the lock down has been implemented properly at Indkuri more Manbazar or not. This refers to Manbazar PS GDE No- 329 Dtd.08.08.21. Accordingly, I along with C/1184 Subhendu Maity HG/1443 Uttam Kr. Singh had been at Indkuri more Manbazar and found the above noted persons were moving freely in that public place without wearing Mask. Thus they violated COVID -19 protocol as promulgated by Govt. of West Bengal Vide Order No-753/III - ISS/2M-22/2020 dated 14.07.2021, & further extended order no- 753/IV-ISS/2M- 22/2020 dtd- 29.07.2021 till ~~now~~ 15.08.2021 and desperately to spared infection of deceases dangerous to life.

I arrested them for Disobedience to order duly promulgated by the Govt. of West Bengal as above after maintaining all rules of arrest, Issued memo of arrest. I informed them & their relative regarding the ground of arrest.


All the process was done in between 21:50 hrs to 23:00 hrs. There was every chance of breach of peace and requiring of offence if not arrested. As there was lock down in the town the peoples left the place and did not agreed to come forward to remain present.


