Sir,

Bipadatan Mandal (28) S/O Shishubhakta Mandal of village- Bara Nuniyani. 5. Ranjit Kr Mahato (60) S/O Lt Kinkar Ch Mahato of village- Bishiri. 6. Prafulla Mahato (47) S/O Lt Kinkar Ch Mahato of village Bishri all are of PS Manbazar, District Purulia, 7. Shaktipada Garain (36) S/O Helu Gorain of village Jorobari, 8. Subhas Ch Roy (54) S/O Lt. I beg to state that today (11.08.2021), I was directed to find out whether the lock down has been implanted properly at Manbazar Town area. or not. This refers to Manbazar PS GDE No- 460 Dtd. 11.08.21. Accordingly, I along with C/ 1429 Jagadish Chandra Mahato HG/1419 Santanu Dutta had been at Bus stand, Manbazar and found the above noted persons were moving freely in that public place without wearing Mask. Thus they violated COVID -19 protocol as promulgated by Govt. of West Bengal Vide Order No-753/III – ISS/2M-22/2021 dated 14.07.2021, Extended till 31 August 2021 and desperately to spread infection of deceases dangerous to life.

I arrested them for Disobedience to order duly promulgated by the Govt. of West Bengal as above after maintaining all rules of arrest, Issued memo of arrest. I informed them & their relatives regarding the ground of arrest.

All the process was done in between 21:45 hrs and 23:00 hrs. There was every chance of breach of peace and requiring of offence if not arrested. As there was lock down in the town the peoples left the place and did not agreed to come forward to remain present.

After that I left for PS. On arrival at PS I type this letter of complaint at our PS computer and submitted to OC Manbazar PS through duty officer ASI Sambal Kumar Singh for taking necessary action as per law.
