Narayan Mahato (21) S/O Kamal Mahato of village - Nadiha, all are of PS Manbazar, District Purulia. 7. Manas Bauri (25) S/O Manindranath Bauri of village Tilabani, 8. I beg to state that today (12.08.21), I was directed to find out whether the lock down has been implanted properly at Manbazar Town area. or not. This refers to Manbazar PS GDE No- 502 Dtd. 12.08.2021. Accordingly, I along with ASI Manik Chandra Mahato & C/ 496 Prakash Ch Mahato C/1211 Chunaram Hembram had been at Gonesh Sweets morh Manbazar and found the above noted persons were moving freely in that public place without wearing Mask. Thus they violated COVID -19 protocol as promulgated by Govt. of West Bengal Vide Order No-753/III - ISS/2M-22/2021 dated 14.07.2021, Extended till 15th August 2021 and desperately to spread infection of deceases dangerous to life.

I arrested them for Disobedience to order duly promulgated by the Govt. of West Bengal as above after maintaining all rules of arrest, Issued memo of arrest. I informed them & their relatives regarding the ground of arrest.

All the process was done in between 21:35 hrs and 22:50 hrs. There was every chance of breach of peace and requiring of offence if not arrested. As there was lock down in the town the peoples left the place and did not agreed to come forward to remain present.

After that I left for PS. On arrival at PS I type this letter of complaint at our PS computer and submitted to OC Manbazar PS through duty officer ASI Anirban Banerjee for taking necessary action as per law.
