Sir,

In producing here with 10 (Ten) arrested accused persons namely 1. Bidyut Gope (22) S/O Sunil Gope of village- Gosaidih, 2. Srikanta Mudi (36) S/O Gurupada Mudi of village Palashbani, 3. Bhabatosh Mahato (50) S/O Lt. Goti Mahato of Ichadih, 4. Baidyanath Mahato (30) S/O Bhalanath Mahato of village- Ichadih, 5. Bikash Rajok (32) S/O Banshidhar Rajok of village Manbazar Rajokpara, 6. Aditya Mahato (22) S/O Panru Mahato of village Bisir, 7. Gopinath Narayan Deb (30) S/O Biswarup Narayan Deb of village Patharmahara, near SDO office, 8. Fatik Bauri (30) S/O Amullya Bauri of village Palashbani all are of PS Manbazar, District Purulia, 9. Bikash Karmakar (21) S/O Bablu Karmakar of village Dharampur, PS Boro, District Purulia, 10. Santanu Banerjee (35) S/O Ajit Kumar Banerjee of village Bagmundi near Thana, PS Bagmundi, District Purulia.

I beg to state that today (15.08.21), I was directed to find out whether the lock down has been implanted properly at Manbazar Town area or not. This refers to Manbazar PS GDE No.621 Dtd. 15.08.21. Accordingly, I along with C/1429 Jagadish Chandra Mahato, HG/1419 Santanu Kumar Dutta had been at Bank morh Manbazar and found the above noted persons were moving freely in that public place without wearing Mask. Thus they violated COVID -19 protocol as promulgated by Govt. of West Bengal Vide Order No-753/III – ISS/2M-22/2021 dated 14.07.2021, Extended till 31<sup>st</sup> August 2021 and desperately to spread infection of deceases dangerous to life.

I arrested them for Disobedience to order duly promulgated by the Govt. of West Bengal as above after maintaining all rules of arrest, Issued memo of arrest. I informed them & their relatives regarding the ground of arrest.

All the process was done in between 22:00 hrs and 22:45 hrs. There was every chance of breach of peace and requiring of offence if not arrested. As there was lock down in the town the peoples left the place and did not agreed to come forward to remain present.

After that I left for PS. On arrival at PS I type this letter of complaint at our PS computer and submitted to OC Manbazar PS through duty officer SI Mahadeb Rana for taking necessary action as per law.
