

- 2) That, on 07.04.2021 at about 07.00 A.M. all the accused persons are forcibly entering into the tank and also catching fishes without any permission from the Complainant and his other co-sharer, when the Complainant raise objection then they given out threats to the Complainant that if the Complainant lodged any complaint before any Authority then they will murder to the Complainant at any time, and also throwing vulgar language to the Complainant and his family members. On the same day the Complainant lodged complain before Manbazar Police Station but due non taking step by Concern Authority the Complainant also lodged complain before S.P. Purulia on 21.04.2021, and when on 11.07.2021 the Accused persons are again catching fishes by show of force without permission from the Complainant and the Accused persons are also trespassed the other properties of the Complainant by show of force in respect of the above plots, though they have no right over the aforesaid plots. Record of Right has been prepared in the name of Complainant and his other cosharers, so the Complainant filed this petition for take appropriate step.


