Sir,

In producing herewith 05 (Five) arrested accused persons namely (1) Ruplal Mandi (45) S/O- Lt. Dukhu Mandi of Vill-Chhatarkanali, PS-Neturia, Dist-Purulia (2) Sk. Ali Asgar (25) S/O- Sk. Abdul Khalik of Vill-Nimdanga, PS-Neturia, Dist-Purulia (3) Sk. Newaz (35) S/O- Lt. Sk. Najrul of Vill-Nimdanga, PS-Neturia, Dist-Purulia (4) Chandan Marandi (19) S/O- Lt. Surendar Marandi of Vill-Ledium, PS-Santuri, Dist-Purulia and (5) Anil Bauri (35) S/O- Lt. Nepal Bauri of Vill-Heddi, PS-Neturia, Dist-Purulia do hereby lodge a written complaint against the above noted accused persons to the effect that today on 02.08.2021 while I, SI Abhijit Das, along with C/78 Utpal Sarkar, C/1260 Santosh Saren and NVF/711 Sunil Singh all are of Neturia PS as per direction engaged in special mobile duty in Neturia PS area, reference Neturia PS GDE No- 78 dated 02.08.2021 for implementation of Government rules regarding lockdown Disaster Management Plan. While we reached at Sarbari More at about 21:15 hrs found that the above noted persons were gathered there without any valid reason and without wearing mask which violates the compliance of norms of Government order as well as wearing of mask during this pandemic situation. I asked them about their presence at Sarbari More but they failed to give any satisfactory answer. So, they violated the compliance of norms of Government order as well as wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule U/S-188/34 IPC & 51 (1) (b) of National Disaster Management Act, 2005. Accordingly, I arrested the above noted accused persons after maintaining all formalities regarding arrest as they committed cognizable offence in presence of police.

Therefore, I pray a specific case may kindly be started against the above noted accused persons U/S- 188/34 IPC and 51 (1) (b) of National Disaster Management Act, 2005 and arrange for its investigation.
