In producing herewith one arrested accused namely Jiten Das (30) S/O- Lt. Pandu Das of Vill-Bewa, PS- Mihijam, Dist-Jamtara, Jharkhand A/P- Shakambari Ispat & Power Ltd. Under PS- Neturia, Dist- Purulia with one improvised country made pipe gun (iron made) approx 25 cm in length, grey colour butt, barrel, trigger, firing pin, hammer etc. along with 01 round live cartridge (.303) to the effect that today on 13.08.21 at 02:15 hrs while I, ASI Rajkumar Goswami along with force C/480 Uttam Bouri, C/939 Laltu Paul & C/1260 Santosh Soren were performing night mobile & Naka duty vide Neturia PS GDE No- 496 & CC No- 2026/21 Dt. 12.08.21 that time received a credible source information that one person is coming from Barakar side to Neturia PS area with an ill motive for committing any serious crime. Accordingly, I informed the matter to you and as per your kind order myself along with force who were engaged in night mobile duty accompanied with me left for D. Ghat to work out the information. After reaching at D. Ghat at about 02:25 hrs, started Naka checking there. After some time we found that one person is coming from Barakar side and seeing the police party he tried to flee away from there by riding on a Scotty and after a hot chase we managed to apprehend him. On being asked he disclosed his identity as noted above. Searched the above noted person very carefully in presence of witnesses and recovered one improvised country made pipe gun (iron made) approx 25 cm in length, grey colour butt, barrel, trigger, firing pin, hammer etc. along with 01 round live cartridge (.303) from his exclusive possession, which was concealed in his waist and on being asked he stated incoherent statement in respect of his presence at the area at that time. There was every reasonable believe that the accused had came down in the area with a view to commit crime by using the illegal fire arms. On demand, he failed to produce any valid documents/ license in respect of the said arms & ammunitions and the Scotty. Accordingly, I seized and labeled in between 02:45 hrs to 03:15 hrs one improvised country made pipe gun with 01 round live cartridge (.303) and one Purple colour TVS Jupiter ZX Two wheeler Scotty vide registration number JH 21L 4514 and having Engine No-DG5LL3601724 & Chassis No- MD626CG5XL3L27575 from his possession under proper seizure list duly signed by the witnesses. During search and seizure I have tried to procure public witnesses to put down signature in the seizure list but the time is dead hour of night so no any person available there and arrested the above noted accused person at 03:25 hrs after observing all the guidelines of Hon'ble Apex Court of India, Hon'ble High Court Calcutta, N.H.R.C & W.B.H.R.C.

Under the above fact and circumstances it is reasonably believe that arrested accused person have committed a serious offence and he is liable for an offence punishable U/S- 25/27 Arms Act

Therefore, I pray that a specific case may kindly be registered against Jiten Das (30) S/O- Lt. Pandu Das of Vill-Bewa, PS- Mihijam, Dist-Jamtara, Jharkhand under proper section of law and arrange its investigation.
