Sir,

In producing herewith 03 (Three) arrested accused persons namely (1) Tarun Mudi (34) S/O- Shyamal Mudi of Vill- Garpanchakot, PS- Neturia, Dist- Purulia, (2) Prakash Kaibarta (25) S/O- Jaharlal Kaibarta of Vill- Garpanchakot, PS- Neturia, Dist- Purulia, (3) Ibrahim Mia (34) S/O- Mustak Mia of Vill- Parbelia New Colony, PS- Neturia, Dist- Purulia do hereby lodge a written complaint against the above noted accused persons to the effect that today on 14.08.2021 while I, SI Biswajit Banarjee, along with C/584 Madhab Ch. Majee, C/-78 Utpal Sarkar, NVF - 660 Ranjit Kumbhakar all are of Neturia PS as per direction engaged in special mobile duty in Neturia PS area, reference Neturia PS GDE No- 586 dated 14.08.2021 for implementation of Government rules regarding lockdown Disaster Management Plan as well as night curfew. While we reached at Parbelia Bazar at about 21:45 hrs found that the above noted persons were gathered there without any valid reason and without wearing mask which violates the compliance of norms of Government order as well as wearing of mask during this pandemic situation. I asked them about their presence at Parbelia Bazar but they failed to give any satisfactory answer. So, they violated the compliance of norms of Government order as well as wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule U/S-188/34 IPC & 51 (1) (b) of National Disaster Management Act, 2005. Accordingly, I arrested the above noted accused persons after maintaining all formalities regarding arrest as they committed cognizable offence in presence of police.

Therefore, I pray a specific case may kindly be started against the above noted accused persons U/S- 188/34 IPC and 51 (1) (b) of National Disaster Management Act, 2005 and arrange for its investigation.
