Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one arrested accused person namely Paritosh Bauri (37) S/O- Dugai Bauri of Vill-Bora, PS-Neturia, Dist-Purulia with seizure of 30 pcs Sealed bottles of Dil Khush Country spirit containing 300 ml each which were seized under proper seizure list.

I beg to submit that today (27.08.21) while I, ASI Rajkumar Goswami, along with force were performing evening mobile duty vide Neturia PS GDE No-1133 Dt. 27.08.21 and acting on source information after consulting you at about 19:05 hrs reached at Sarbari-More and held raid in the house of Paritosh Bauri (37) S/O- Dugai Bauri of Vill-Bora, PS-Neturia, Dist-Purulia and found that the above noted person was keeping / selling liquor which were kept in his house, on demand Paritosh Bauri failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A (c) B.E. Act and he was arrested U/S-67 BE Act and also 30 pcs Sealed bottles of Dil Khush Country spirit containing 300 ml each which were seized under proper seizure list duly signed by witnesses and labeled 01 (One) bottle at the time of seizure. During arrest, I followed all the guidelines of Ld. Apex Court, NHRC & WBHRC and the ground of arrest was duly notified and informed his relative, issued arrest memo u/s- 50 Cr. P.C. and handed a copy of the same to arrestee.

The arrested accused namely Paritosh Bauri (37) S/O- Dugai Bauri of Vill-Bora, PS-Neturia, Dist-Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid (1) C/584 Madhab Chandra Majee (2) C/1140 Dayamay Mahato and (3) NVF/546 Ajit Singh all are of Neturia PS accompanied me.

Under the above facts and circumstances I therefore pray that a specific case may kindly be started against Paritosh Bauri (37) S/O- Dugai Bauri of Vill-Bora, PS-Neturia, Dist-Purulia under proper section of law.
