In producing herewith 06 (Six) arrested accused persons namely (1) Swapan Kabi (52) S/O- Lt. Accordingly, I arrested the above noted accused persons after maintaining all formalities regarding arrest as they committed cognizable offence in presence of police.

Therefore, I pray a specific case may kindly be started against the above noted accused persons U/S- 188/34 IPC and 51 (1) (b) of National Disaster Management Act, 2005 and arrange for its investigation.
