In producing herewith 14 (Fourteen) arrested accused persons namely 1) Bhajahari Bouri (38) S/o Gobardhan bouri, 2) Kartik Bouri (36) S/o Lt. Srikanta Bouri, 3) Gobinda Bouri (23) S/o Pravash Bouri all of Vill- Dubra (Keliassota), 4) Bhutu Roy (48) S/o Narugopal Roy of Vill- Patharkuchi all of PS- Para, Dist- Purulia, 5) Manik Soren (32) S/o Lt. Rajaram Soren of Vill- Babiddi, PO- Gourangadih, 6) Pradip Kr. Tudu (24) S/o Rabi Tudu of Vill- Gamarkuli both of PS- Kashipur, Dist- Purulia, 7) Amarjeet Bhakat (22) S/o Mahesh Bhakat of Sisu Bagan, Korapara, PS- Raniganj, Dist- Purba Bardhaman, 8) Shibdas Mal (48) S/o Lt. Kalipada Mal of Vill- Gogre, PS- Onda, Dist- Bankura, 9) Sazi Ahmad (34) S/o Md. I beg to state that today (02.08.2021), I was directed to find out whether wearing of mask by the public has been properly maintained at Koldih More or not and also to observe Lock down protocol at night from 09.00 PM to 05.00 AM. Accordingly, I had been to Koldih More at about 21.15 hrs and found that a gathering appeared at Koldih More, none of them were wearing mask. On seeing Police they tried to escape from the grip of police party but some failed to escape due to efficient effort of Police. On being asked they disclosed their identity as noted above.

In this pandemic situation of CORONA Virus/COVID-19 the above noted persons violated the order duly promulgated by government through public servants and through media by strolling, riding without mask instead of following the COVID rules of wearing mask and not to stroll after 09.00 PM as there is complete lockdown after 09.00 PM to 05.00 AM. They are creating annoyance in that locality & violated Govt. order No- 753-ISS/2M-22/2020 Dtd- 14.07.2021 for complete restriction measure. So, I arrested them for Disobedience of order duly promulgated by public servant after maintaining all rules of arrest, Issued memo of arrest. I informed them & their relatives regarding the ground of arrest i.e.as per section 3 of the Epidemic Diseases Act, 1897, provide penalties for disobeying any regulation or order made under the Act and released them on bail. At prima facie there were sufficient evidences to secure their detention. All the process was done in between 21.25 hrs to 22.35 hrs.

Therefore, I pray a specific case may kindly be lodge against 1) Bhajahari Bouri (38) S/o Gobardhan bouri, 2) Kartik Bouri (36) S/o Lt. Srikanta Bouri, 3) Gobinda Bouri (23) S/o Pravash Bouri all of Vill- Dubra (Keliassota), 4) Bhutu Roy (48) S/o Narugopal Roy of Vill- Patharkuchi all of PS- Para, Dist- Purulia, 5) Manik Soren (32) S/o Lt. Rajaram Soren of Vill- Babiddi, PO- Gourangadih, 6) Pradip Kr. Tudu (24) S/o Rabi Tudu of Vill- Gamarkuli both of PS- Kashipur, Dist- Purulia, 7) Amarjeet Bhakat (22) S/o Mahesh Bhakat of Sisu Bagan, Korapara, PS- Raniganj, Dist- Purba Bardhaman, 8) Shibdas Mal (48) S/o Lt. Kalipada Mal of Vill- Gogre, PS- Onda, Dist- Bankura, 9) Sazi Ahmad (34) S/o Md. Kamaruddin Ansary of Ward No- 12, PS- Kachhra, Dist- Madhubani (Bihar) and 10) Lakhu Gope (23) S/o Haken Gope of Vill- Gundibhitha, PS- Chandankeyari, Dist- Bokaro (Jharkhand) as they disobeyed Govt. order and committed negligent Act likely to spread infection of diseases dangerous to lie and violated the rule.
