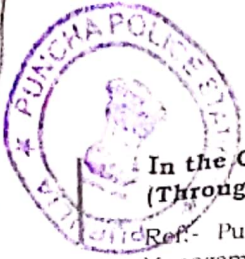

The fact of the case is that on 01/08/2021 received a typed complaint from SI Chandidas Chakraborty as when he was engaged in mobile duty at near Pancha Kishan Mandi area with force to find out whether the people of this jurisdiction are following norms of wearing mask & social distancing properly at PS jurisdiction area or not vide Pancha PS GDE No- 11, Dtd- 01/08/2021 at about 14.15 hrs, he found the people that namely namely (1) Sushil Sing Sardar (23), S/O- Rabolochan Sing Sardar of vill-Butgora, PS- Pancha, Dist Purulia (2) Suraj Bouri (22), S/O Bahadur Bouri of vill-Lakhra, PS- Pancha, Dist Purulia (3) Dayamoy Gope Mandal (22), S/O- Lalmohan Gope Mandal of vill-Dulalpur, PS- Ranibandh, Dist Bankura (4) Pratham Hansda (25), S/O- Budhan Hansda of vill-Mrigipahari, PS- Kashipur, Dist Purulia (5) Malinda Baskey (45) S/O Lt. Ramdhan Baskey of Vill- Asanboni, PS - Pancha Dist- Purulia (6) Mahitosh Hembram (24) S/O Bridaban Hembram of vill- Natundih, PS- Hirbandh, Dist Bankura (7) Bhuban Ch. Mahato (59) S/O Lt. Amulya Singh Bhuinya of vill- Kushumtikri PS- Pancha, Dist- Purulia were roaming aimlessly without wearing mask so he detained them and on being asked the accd people could not give any satisfactory answer regarding their movement on public place without using mask. As they refused to comply the direction given by Govt to combat covid-19 pandemic and they committed negligent act likely to spread infection of diseases dangerous to life and violated Government rules which was promulgated by Govt through public servants and through media etc for prevention of attack hence he arrested them after issuing arrest memo and informed them the ground of arrest duly signed by the accd people as per section 3 of the Epidemic Diseases Act, 1897, for disobeying Govt order vide (Memo No-486-CS/2021 Dated-24th April, 2021) of compulsory wearing of mask during this pandemic situation. Over this started Pancha PS case no.-53/21, dtd-01/08/21, U/S 188/34 IPC and Sec 51(1)(b) of National Disaster Management Act, 2005 and O/C Pancha PS endorsed to me to investigate this case.

There after Sanjay Kr. Dutta, S/O- Buddheswar Dutta of Vill-Dhadki, PS-Pancha Dist- Purulia came to PS and turned up surety for arrested accd persons namely (1) Sushil Sing Sardar (23), S/O- Rabolochan Sing Sardar of vill-Butgora, PS- Pancha, Dist Purulia (2) Suraj Bouri (22), S/O Bahadur Bouri of vill-Lakhra, PS- Pancha, Dist Purulia (3) Dayamoy Gope Mandal (22), S/O- Lalmohan Gope Mandal of vill-Dulalpur, PS- Ranibandh, Dist Bankura (4) Pratham Hansda (25), S/O- Budhan Hansda of vill-Mrigipahari, PS- Kashipur, Dist Purulia (5) Malinda Baskey (45) S/O Lt. Ramdhan Baskey of Vill- Asanboni, PS - Pancha Dist- Purulia (6) Mahitosh Hembram (24) S/O Bridaban Hembram of vill- Natundih, PS- Hirbandh, Dist Bankura (7) Bhuban Ch. Mahato (59) S/O Lt.
