I beg to state that today (03/08/2021) I was engaged in mobile duty at near Puncha Kisan Mandi with force to find out whether people are following norms of wearing mask & social distancing properly at PS jurisdiction area or not. This refers to Puncha PS GDE No- 100 Dtd- 03/08/2021. Accordingly when I was performing duty near Puncha Kisan Mandi I found the above noted people were roaming aimlessly without wearing mask. Firstly I instructed them to wear mask in this pandemic situation but they did not pay heed to my words. Hence I detained them and on being asked the accd people could not give any satisfactory answer regarding their movement on public place without using mask. As they refused to comply the direction given by Govt to combat covid-19 pandemic and they committed negligent act likely to spread infection of diseases dangerous to life and violated Government rules which was promulgated by Govt through public servants and through media etc for prevention of attack hence I arrested them for disobeying Govt order vide (Memo No-486-CS/2021 Dated-24th April, 2021) duly signed by the accd people. The whole process was done in between 10.15 hrs to 12.55 hrs.

Therefore, I pray that a specific case may kindly be started against namely (1) Sukhen Hansda (19), S/O- Lt. Biren Hansda of vill-Gobindapur, (2) Debasish Gope (51), S/O Lt. Bhutnath Gope of vill Mahuladanga, (3) Santanu Mahata (36), S/O- Prabhakar Mahata of vill-Puncha, (4) Manoj Bauri (28), S/O- Shaktipada Bauri of Laulara (5) Shaktipada Sing Sardar (43) S/O Bibhuti Sing Sardar of Vill- Bangora, all of PS – Puncha, Dist- Purulia (6) Dinesh Bauri (35) S/O Mantu Bauri of vill -Muchaikuli, PS- Manbazar, Dist Purulia (7) Shaktipada Hansda (30 yrs) S/O Ashutosh Hansda of vill- Kprra, PS- Manbazar, Dist- Purulia (8) Ukil Saren (29 yrs) S/O Lt.
