**Sub: Complain to start a specific case.**

Sir,

In producing here with 09 (Nine) arrested persons namely (1) Hiralal Mahato (38 ), S/O- Ghanashyam Mahato of vill-Pakbirra, PS- Puncha, Dist Purulia (2) Tarani Sing Patar (30), S/O Lt. Bhakta Sing Patar of vill-Bangora, PS- Puncha, Dist Purulia (3) Chhoton Bauri (26), S/O- Paban Bauri of vill Bhagabandh, PS - Puncha, Dist Purulia (4) Gurupada Bauri (40), S/O- Lt. Mohan Bauri of vill-Bhagabandh PS- Puncha, Dist Purulia (5) Krishnapada Majhi (46) S/O Lt. Satish Majhi of Vill Bandhbahal PS - Puncha Dist- Purulia (6) Sanjoy Bagdi (35) S/O Lt. Gangadhar Bagdi of vill- Pandui, PS- Puncha, Dist Purulia (7) Dilip Hansda (37) S/O Lt. Buddheswar Hansda of vill- Gobindapur, PS- Puncha, Dist- Purulia (8) Karimulla Khan (32) S/O Lt. I beg to state that today (03/08/2021) I was engaged in mobile duty at near Kisan Mandi with force to find out whether people are following norms of wearing mask & social distancing properly at PS jurisdiction area or not. This refers to Puncha PS GDE No- 145 Dtd- 03/08/2021. Accordingly when I was performing duty at near Kisan Mandi I found the above noted people were roaming aimlessly without wearing mask. Firstly I instructed them to wear mask in this pandemic situation but they did not pay heed to my words. Also they are roaming aimlessly with violating the Govt.order that move of people from 09 PM to 05 AM. Hence I detained them and on being asked the accd people could not give any satisfactory answer regarding their movement on public place without using mask. As they refused to comply the direction given by Govt to combat covid-19 pandemic and they committed negligent act likely to spread infection of diseases dangerous to life and violated Government rules which was promulgated by Govt through public servants and through media etc for prevention of attack hence I arrested them for disobeying Govt order vide (Memo No-486-CS/2021 Dated-24<sup>th</sup> April, 2021 & GO No. 753/IV-ISS/2M-22/2020 dtd. 29.07.2021) duly signed by the accd people. The whole process was done in between 21.15 hrs to 22.55 hrs.

Therefore, I pray that a specific case may kindly be started against (1) Hiralal Mahato (38 ), S/O- Ghanashyam Mahato of vill-Pakbirra, PS- Puncha, Dist Purulia (2) Tarani Sing Patar (30), S/O Lt. Bhakta Sing Patar of vill-Bangora, PS- Puncha, Dist Purulia (3) Chhoton Bauri (26), S/O- Paban Bauri of vill Bhagabandh, PS - Puncha, Dist Purulia (4) Gurupada Bauri (40), S/O- Lt. Mohan Bauri of vill-Bhagabandh PS- Puncha, Dist Purulia (5) Krishnapada Majhi (46) S/O Lt. Satish Majhi of Vill Bandhbahal PS - Puncha Dist- Purulia (6) Sanjoy Bagdi (35) S/O Lt. Gangadhar Bagdi of vill- Pandui, PS- Puncha, Dist Purulia (7) Dilip Hansda (37) S/O Lt. Buddheswar Hansda of vill- Gobindapur, PS- Puncha, Dist- Purulia (8) Karimulla Khan (32) S/O Lt.
