Sir,

In producing here with 10 (Ten) arrested persons namely (1) Pradyut Mahato (49), S/O- Lt. Badal Ch. Mahato of vill-Napara, (2) Tribhanga Goswami (54), S/O Lt. Basudeb Goswami of vill Pandui, (3) Partha Gorai (35), S/O- Lt. Shibsankar Gorai of vill-Bramhanpara,(4) Helal Ansary (25),S/O- Ayub Ansary of vill- Uparbaid (5) Iswar Baskey (36) S/O Sanatan Baskey of Vill- Pakbirra, (6) Sk Osman Ali (40) S/O Lt. Sk Abbas Ali of vill -Saragora,(Puncha) (7) Sasadhar Sahis (53) S/O Lt. Mohan Ch. Sahis of vill- Namu. Puncha, (8) Sudhir Mahato (56 yrs) S/O Sripati Mahato of vill- Butgora, (9) Rajaram Mandal (50) S/O Lt. I beg to state that today (04/08/2021) I was engaged in mobile duty at near Puncha Kisan Mandi with force to find out whether people are following norms of wearing mask & social distancing properly at PS jurisdiction area or not. This refers to Puncha PS GDE No- 164 Dtd- 04/08/2021. Accordingly when I was performing duty near Puncha Kisan Mandi I found the above noted people were roaming aimlessly without wearing mask. Firstly I instructed them to wear mask in this pandemic situation but they did not pay heed to my words. Hence I detained them and on being asked the a/cd people could not give any satisfactory answer regarding their movement on public place without using mask. As they refused to comply the direction given by Govt to combat covid-19 pandemic and they committed negligent act likely to spread infection of diseases dangerous to life and violated Government rules which was promulgated by Govt through public servants and through media etc for prevention of attack hence I arrested them for disobeying Govt order vide (Memo No-486-CS/2021 Dated-24th April, 2021) duly signed by the a/cd people. The whole process was done in between 11.35 hrs to 13.15 hrs.

Therefore, I pray that a specific case may kindly be started against namely (1) Pradyut Mahato (49), S/O- Lt. Badal Ch. Mahato of vill-Napara, (2) Tribhanga Goswami (54), S/O Lt. Basudeb Goswami of vill Pandui, (3) Partha Gorai (35), S/O- Lt. Shibsankar Gorai of vill-Bramhanpara,(4) Helal Ansary (25),S/O- Ayub Ansary of vill- Uparbaid (5) Iswar Baskey (36) S/O Sanatan Baskey of Vill- Pakbirra, (6) Sk Osman Ali (40) S/O Lt. Sk Abbas Ali of vill -Saragora,(Puncha) (7) Sasadhar Sahis (53) S/O Lt. Mohan Ch. Sahis of vill- Namu, Puncha, (8) Sudhir Mahato (56 yrs) S/O Sripati Mahato of vill- Butgora, (9) Rajaram Mandal (50) S/O Lt. Rakhahari Mandal of vill- Mishradeoli, all of PS- Puncha, Dist- Purulia (10) Mrityunjoy Mahato (30) S/O Sadhucharan Mahato of Vill- Beldih, PS- Boro, Dist- Purulia as they disobeyed Govt order and committed negligent act likely to spread infection of diseases dangerous to life U/S 188/34 IPC and Sec 51(1)(b) of the National Disaster Management Act, 2005 and arrange for its investigation.
