Sir,

In producing here with 04 (Four) arrested persons namely (1) Bapi Sing Sardar (32), S/O- Lt. Dulal Sing Sardar of vill-Badra, PS- Puncha, Dist Purulia (2) Jhulan Singh (31), S/O Kamalakanta Singh of vill Badra, PS- Puncha, Dist Purulia (3) Gomasta Prasad Soren (23), S/O- Lt.Tikaram Soren of vill Chalka, PS - Boro, Dist Purulia (4) Arup Kr. Mahato (27), S/O- Mihir Kr. Mahato of vill-Maguria, PS- Hura, Dist Purulia along with Memo of arrest & other relevant papers.


I beg to state that today (04/08/2021) I was engaged in mobile duty at Dalaha more with force to find out whether people are following norms of wearing mask & social distancing properly at PS jurisdiction area or not. This refers to Puncha PS GDE No- 182 Dtd- 04/08/2021. Accordingly when I was performing duty at Dalaha more. I found the above noted people were roaming aimlessly without wearing mask. Firstly I instructed them to wear mask in this pandemic situation but they did not pay heed to my words. Also they are roaming aimlessly with violating the Govt.order that move of people from 09 PM to 05 AM. Hence I detained them and on being asked the accd people could not give any satisfactory answer regarding their movement on public place without using mask. As they refused to comply the direction given by Govt to combat covid-19 pandemic and they committed negligent act likely to spread infection of diseases dangerous to life and violated Government rules which was promulgated by Govt through public servants and through media etc for prevention of attack hence I arrested them for disobeying Govt order vide (Memo No-486-CS/2021 Dated-24th April, 2021 & GO No. 753/IV-ISS/2M-22/2020 dtd. 29.07.2021) duly signed by the accd people. The whole process was done in between 21.05 hrs to 21.45 hrs.
