In producing here with 05 (five) arrested persons namely (1) Pallab Ruhidas(21), S/O- Muruli Ruhidas of vill-Puncha (2) Haru Modak(22), S/O-Santosh Modak of vill-Puncha Tamlipara (3) Shubhankar Sahis(26), S/O- Santipada Sahis of vill-Bhutam (4) Md. Sabir (35), S/O- Sattar Ansary of vill-Dalaha (5) Ukil Bauri(22), S/O- Birbal Bauri of vill-Loulara, all of PS-Puncha, Dist- Purulia along with Memo of arrest & other relevant papers.

I beg to state that today (07/08/2021) I was engaged in mobile duty near Puncha Kishan Mandi with force to find out whether people are following norms of wearing mask & social distancing properly at PS jurisdiction area or not. This refers to Puncha PS GDE No- 342 Dtd- 07/08/2021. Accordingly when I was performing duty at near Puncha Kishan Mandi .I found the above noted people were roaming aimlessly without wearing mask. Firstly I instructed them to wear mask in this pandemic situation but they did not pay heed to my words. Also they are roaming aimlessly with violating the Govt.order that move of people from 09 PM to 05 AM. Hence I detained them and on being asked the accd people could not give any satisfactory answer regarding their movement on public place without using mask. As they refused to comply the direction given by Govt to combat covid-19 pandemic and they committed negligent act likely to spread infection of diseases dangerous to life and violated Government rules which was promulgated by Govt through public servants and through media etc for prevention of attack hence I arrested them for disobeying Govt order vide (Memo No-486-CS/2021 Dated-24th April, 2021 & GO No. 753/IV-ISS/2M-22/2020 dtd. 29.07.2021) duly signed by the accd people. The whole process was done in between 21.25 hrs to 22.25 hrs.
