To The Officer -in- Charge, Puncha P.S., District - Purulia.

Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one arrested accused person namely Anil Sahis(35 yrs), S/O- Lt. Ankur Sahis of vill-Ledamohul PS-Puncha, Dist-Purulia with seizure of 12 (twelve) bottle of Dil Se Country spirit containing 300 ml each which were seized under proper seizure list.

I beg to submit that today (08.08.21) while I, ASI Susanta Mishra, along with force were performing evening mobile duty vide Puncha PS GDE No-383 Dt. 08.08.21 and acting on source information after consulting you at about 17.05 hrs reached at Ledamohul village and held raid in the house of Anil Sahis (35 yrs), S/O- Lt. Ankur Sahis of vill-Ledamohul PS-Puncha, Dist-Purulia and found that the above noted person was keeping / selling liquor which were kept in his house, on demand Anil Sahis failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A (c) B.E. Act and he was arrested and also 12 (twelve) bottle of Dil Se Country spirit containing 300 ml each which were seized under proper seizure list duly signed by witnesses and labeled out of which 01 (One) bottle Dil Se collected as a sample at the time of seizure. During arrest, I followed all the guidelines of Ld. Apex Court, NHRC & WBHRC and the ground of arrest was duly notified and informed his relative, issued arrest memo and handed a copy of the same to arrestee.

The arrested accused namely Anil Sahis(35 yrs), S/O- Lt. Ankur Sahis of vill-Ledamohul PS-Puncha, Dist-Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid (1) C/1487 Tarani Sen Das and (2) NVF/223 Himalay Mahato and both of Puncha PS accompanied me.

Under the above facts and circumstances I therefore pray that a specific case may kindly be started against Anil Sahis(35 yrs), S/O- Lt. Ankur Sahis of vill-Ledamohul PS-Puncha, Dist-Purulia under proper section of law.
