

## Most respectfully begs to state:-

- That the Complainant is a permanent resident of Vill + P.O- Naupara, P.S-Puncha, Dist- Purulia.
- 2) That the accused person namely Rajesh Rakshit S/o- Sri Mansaram Rakshit, a resident of Vill- Dhadki, P.O- Laulara, P.S- Puncha, Dist-Purulia, used to work as an agent of LIC, and by virtue of his work some LIC Policies were opened by the Complainant through the accused person, and the complainant used to make payments of the said premiums periodically.
- 3) That being the agent of LIC and as the complainant opened some LIC policies through the accused person, a familiar relationship grown between the parties, and taking advantages of familiar relationship the accused person approached the complainant to part with a loan of Rs. 2,30,000/- for construction of house.
- 4) That firstly the complainant was reluctant, but seeing the persistent approach of the accused person and considering the good relationship, the complainant has paid a sum of Rs. 2,30,000/- in the last part of 2016, and the accused person auusred the complainant to repay the said sum within one year.
- That after lapse of one year when the complainant demanded the said sum, the accused person expressed his inability to pay the amount at a time and





approached the complainant that he would pay the LIC premiums of the complainant periodically. On good faith the complainant agreed for the same and in the year of 2018 the accused person executed a declaration in presence of Rabi Dutta and Achin Dutta to repay the amount in monthly instalments and also declared that he will make payments of LIC premiums of the complainant.

- 6) After lapse of a considerable period, when the complainant asked the accused person to give the premium receipts, the accused person each and every time avoided the same with lame excuse. Finally, after 2<sup>nd</sup> Phase Lockdown the complainant had been to the office of LIC and get the statement on 14.06.2021, and found no premiums has been deposited against his policies. Being astonished, the complainant went to the house of the accused person on 26.06.2021, but the accused person became violent and started abusing the complainant with filthy languages and flatly refused to talk with the complainant and closed the door after kicked him out.
- 7) That under the circumstances set forth above, it is crystal clear that the accused Rajesh Rakshit being an agent of LIC, by making false representation with intend to deceive the complainant, take a sum of Rs. 2,30,000/- and misappropriated the said sum, causing wrongful gain to himself and wrongful loss to the complainant and thereby committed the offences of cheating and other various offences.
- 8) That the above mentioned matter was duly intimated to the Officer-in-charge of Puncha P.S on 29.06.2021 but the police of Puncha P.S. refused to accept the same, the reason is best known to them, thereafter the said complaint was send to The officer-in-charge of Puncha P.S through registered post on 06.07,2021, but till date no action has been taken.
- 9) That subsequently the Complainant on 19.07.2021 informed the matter to the Superintendent of Police, Purulia but even then as no step has been taken against the Accused Persons by the police, the Complainant is being compelled to lodged this Petition u/s 156 (3) Cr.P.C. before Your Honour's Court.







10) That the Complainant is unable to arrange for producing the Witnesses in Court as the Accused Person is most powerful political personality having muscle power also and are most dangerous persons and the persons, who witnessed the incident, are threatened by the Accused Persons of dire consequences if they will give evidence in support of the Complainant. Moreover in the instant case various documents are to be seized which could not be possible without police help.

It is therefore prayed that your Honour will be graciously pleased to send this petition to O/C Puncha P.S. to treat this petition as an FIR as contemplated u/s 156(3) Cr. P.C. and to investigate the case in accordance with law and to unearth the wrongdoer
