In producing here with 05 (five) arrested persons namely (1) Manoj Kr. Mahato(32), S/O- Sadananda Mahato of vill- Delang, PS-Puncha, Dist- Purulia (2) Samir Kr. Dutta(58), S/O- Bhabatarn Dutta of vill+PO-Bagda, PS- Puncha, Dist- Purulia (3) Haru Bauri(50), S/O- Lt. Panru Bauri of vil+PO-Gopalpur, PS-Puncha, Dist- Purulia (4) Madhusudan Gorai(36), S/O-Gurupada Gorai of vill-Napara, PS-Puncha, Dist- Purulia (5) Satyajit Mahato(21), S/O- Prakash Mahato of vill-Sarochalkalta, PO-Napara, PS- Puncha, Dist- Purulia along with Memo of arrest & other relevant papers.

I beg to state that today (13/08/2021) I was engaged in spl mobile duty at near Puncha Kishan Mandi with force to find out whether people are following norms of wearing mask & social distancing properly at PS jurisdiction area or not. This refers to Puncha PS GDE No- 571 Dtd- 13/08/2021. Accordingly when I was performing duty at near Puncha Kishan Mandi . I found the above noted people were roaming aimlessly without wearing mask. Firstly I instructed them to wear mask in this pandemic situation but they did not pay heed to my words. Hence I detained them and on being asked the aced people could not give any satisfactory answer regarding their movement on public place without using mask. As they refused to comply the direction given by Govt to combat covid-19 pandemic and they committed negligent act likely to spread infection of diseases dangerous to life and violated Government rules which was promulgated by Govt through public servants and through media etc for prevention of attack hence I arrested them for disobeying Govt order vide (Memo No-486-CS/2021 Dated-24th April, 2021) duly signed by the aced people. The whole process was done in between 16.45 hrs to 17.25 hrs.
