Sir,

In producing here with 05 (five) arrested persons namely (1) Sanjoy Bauri(32), S/O- Lt. Hilom Bauri of vill- Polmi, PS- Puncha, Dist- Purulia (2) Nishakur Mahato(24), S/O- Lt. Krishnapada Mahato of vil- Radhanagar, PS- Puncha, Dist- Purulia (3) Partha Sarathi Ojha(46), S/O- Lal Mohan Ojha of vil- Hutmura, PS- Purulia(M), Dist- Purulia (4) Mahammad Sayed Ali Khan(32), S/O- Najrul Khan of vil- Bhimpur, PS- Hirbandh, Dist- Bankura (5) Bimal Saren(22), S/O- Nagendranath Saren of vil- Moujodi, PS- Manbazar, Dist- Purulia with Memo of arrest & other relevant papers.

I beg to state that today (26/08/2021) I was engaged in mobile duty at Pairachali market, with force to find out whether people are following norms of wearing mask & social distancing properly at PS jurisdiction area or not. This refers to Puncha PS ODE No- 1170 Dtd- 26/08/2021. Accordingly when I was performing duty at Pairachali market, I found the above noted people were roaming aimlessly without wearing mask. Firstly I instructed them to wear mask in this pandemic situation but they did not pay heed to my words. Hence I detained them and on being asked the accd people could not give any satisfactory answer regarding their movement on public place without using mask. As they refused to comply the direction given by Govt to combat covid-19 pandemic and they committed negligent act likely to spread infection of disease dangerous to life and violated Government rules which was promulgated by Govt through public servants and through media etc for prevention of attack hence I arrested them for disobeying Govt order vide (Memo No-486-CS/2021 Dated-24<sup>th</sup> April, 2021) duly signed by the accd people. The whole process was done in between 12.45 hrs to 13.35 hrs.

Therefore, I pray that a specific case may kindly be started against (1) Sanjoy Bauri(32), S/O- Lt. Hilom Bauri of vill- Polmi, PS- Puncha, Dist- Purulia (2) Nishakur Mahato(24), S/O- Lt. Krishnapada Mahato of vil- Radhanagar, PS- Puncha, Dist- Purulia (3) Partha Sarathi Ojha(46), S/O- Lal Mohan Ojha of vil- Hutmura, PS- Purulia(M), Dist- Purulia (4) Mahammad Sayed Ali Khan(32), S/O- Najrul Khan of vil- Bhimpur, PS- Hirbandh, Dist- Bankura (5) Bimal Saren(22), S/O- Nagendranath Saren of vil- Moujodi, PS- Manbazar, Dist- Purulia as they disobeyed Govt order and committed negligent act likely to spread infection of disease dangerous to life, U/S 188/34 IPC and Sec 51(1)(b) of the National Disaster Management Act, 2005 and arrange for its investigation.
