Sir,

In producing here with 05 (five) arrested persons namely (1) SK Sajahan(40), S/O- Lt. SK Jafar of vill-Khatra Muslim Para, PS-Khatra, Dist- Bankura (2) Ramen Char Modak(26), S/O- Dinabandhu Char Modak of vill-Manbazar Ganak Para, PS-Manbazar, Dist- Purulia (3) Bhim Tudu(25), S/O-Lt. Naran Tudu of vill-Dhagara, PS- Puncha, Dist- Purulia (4) Amar Bauri(25), S/O- Amrit Bauri of vill-Tushyama, PS-Puncha, Dist- Purulia (5) Jiten Bauri(35), S/O-Ramesh Bauri of vill-Basudi, PS-Manbazar, Dist- Purulia with Memo of arrest & other relevant papers.

I beg to state that today (27/08/2021) I was engaged in mobile duty at near Kishan Mandi with force to find out whether people are following norms of wearing mask & social distancing properly at PS jurisdiction area or not. This refers to Puncha PS GDE No- 1203 Dtd- 27/08/2021. Accordingly when I was performing duty at near Kishan Mandi . I found the above noted people were roaming aimlessly without wearing mask. Firstly I instructed them to wear mask in this pandemic situation but they did not pay heed to my words. Hence I detained them and on being asked the accd people could not give any satisfactory answer regarding their movement on public place without using mask. As they refused to comply the direction given by Govt to combat covid-19 pandemic and they committed negligent act likely to spread infection of diseases dangerous to life and violated Government rules which was promulgated by Govt through public servants and through media etc for prevention of attack hence I arrested them for disobeying Govt order vide (Memo No-486-CS/2021 Dated-24th April, 2021) duly signed by the accd people. The whole process was done in between 15.15 hrs to 16.05 hrs.

Therefore, I pray that a specific case may kindly be started against (1) SK Sajahan(40), S/O- Lt. SK Jafar of vill- Khatra Muslim Para, PS-Khatra, Dist- Bankura (2) Ramen Char Modak(26), S/O-Dinabandhu Char Modak of vill-Manbazar Ganak Para, PS-Manbazar, Dist- Purulia (3) Bhim Tudu(25), S/O-Lt. Naran Tudu of vill-Dhagara, PS- Puncha, Dist- Purulia (4) Amar Bauri(25), S/O- Amrit Bauri of vill-Tushyama, PS- Puncha, Dist- Purulia (5) Jiten Bauri(35), S/O-Ramesh Bauri of vill-Basudi, PS-Manbazar, Dist- Purulia as they disobeyed Govt order and committed negligent act likely to spread infection of diseases dangerous to life, U/S 188/34 IPC and Sec 51(1)(b) of the National Disaster Management Act, 2005 and arrange for its investigation.
