Debu Paul of Vill-Bhangra, PS-Purulia (M), Dist-Purulia, 2) Basudev Rajwar (48 Yrs) S/o- Chanda Rajwar of Vill-Shyamlota, PS-Hura, Dist-Purulia, 3) Sanatan Kalindi (20 yrs) S/o Lambodhar Kalindi of Vill-Girgiri, PS-Purulia (M), Dist-Purulia, 4) Judisthir Rajwar (35 Yrs) S/O-Laxmi Pada Rajwar of Vill-Upar Surulia, PS-Purulia (M), Dist-Purulia, 5) Chutu Mahato (45 Yrs) S/O-Baniram Mahato of Vill-Kanapara, , PS-Kenda, Dist-Purulia,

The fact of the case in a nut shell is that I SI Suvankar Sarkar along with force namely i) C/1413 Kanai Lal Mandal, ii) C/254 Karunamoy Bauri iii) C/1175 Srikanta Mukherjee of Purulia (M) PS performing the Spl. Mobile duty for the implementation of partial Lock Down in the area vide Purulia (M) PS GDE No 377 dtd. 08.08.2021 in consonance with C.C No 2243/21 Dtd. 08.08.2021 as per order of superior. During my Mobile Duty, while I arrived at Lagda morh at 21:05 hrs. and found 05 (five) persons noted in the supra were confabulating among themselves sitting beside the road without wearing the mask and maintaining the social distance at the partial lock down in all over the state. On being asked they could not give sufficient reason or satisfactory answer of their unwarranted confabulation beside the road after violating the Government order in this pandemic situation. Consequently, it reasoned to believe that they violated the order and disobeyed the direction during this pandemic situation duly promulgated by Govt. of West Bengal vide Memo No 647-ISS/2M-22/2020 dtd. 15/05/2021 in consonance with order promulgated by Govt. of West Bengal vide Memo No 486-CS/2021 dtd. 24/04/2021 following with the order of Govt. of West Bengal vide Memo No-707-ISS/2M-22/20 dtd. 29.05.21. Consequently, the supra noted persons were arrested on the spot and informed them the ground of their arrest and issued memo of arrest in respect of them.

As the supra noted persons violated the order and disobeyed the direction during this pandemic situation duly promulgated by Govt. of West Bengal vide Memo No 647-ISS/2M-22/2020 dtd. 15/05/2021 in consonance with order promulgated by Govt. of West Bengal vide Memo No 486-CS/2021 dtd. 24/04/2021 following with the order of Govt. of West Bengal vide Memo No-707-ISS/2M-22/20 dtd. 29.05.21 so they can be booked U/S 188/34 of the IPC and read with section 51 of the National Disaster Management Act 2005. So a specific case may kindly be initiated against them and arranged for its investigation.
