

In producing herewith the 05 (five) persons namely 1) Tufan Mudi (21 Yrs) S/O Umesh Mudi of Vill-Bilchari, PO-Hensla, PS-Arsha, Dist-Purulia 2) Sk Raju (23 yrs) S/o Sk Salim of Vill-Hutmura, PS-Purulia (M), Dist-Purulia, 3) Afroj Sha (30 yrs) S/o Sadhu Sha of Vill+PO- Chepra, PS-Purulia (M), Dist-Purulia, 4) Sumanta (30 yrs) S/o Gour Mahato of Vill-Kannukhap, PS-Joypur, Dist-Purulia, 5) Sk Riyajuddin (28 yrs) S/o Sk Nuhu of Vill-Kustuka, PS-Purulia (M), Dist-Purulia.

The fact of the case in a nut shell is that I SI Goutam Kr. Mahata along with force namely i) C/1187 Samar Kanta Maity, ii) C/1250 Jitendra Kr. Dubey iii) C/1479 Anup Mahato of Purulia (M) PS performing the Spl. Mobile duty for the implementation of partial Lock Down in the area vide Purulia (M) PS GDE No 499 dtd. 20.08.2021 in consonance with C.C No 2263/21 Dtd. 10.08.2021 as per order of superior. During my Mobile Duty, while 1 arrived at Nadiara Morh at 21:35 hrs. and found 05 (five) persons noted in the supra were confabulating among themselves sitting beside the road without wearing the mask and maintaining the social distance at the partial lock down in all over the state. On being asked they could not give sufficient reason or satisfactory answer of their unwarranted contabulation beside the road after violating the Government order in this pandemic situation. Consequently, it reasoned to believe that they violated the order and disobeyed the direction during this pandemic situation duly promulgated by Govt. of West Bengal vide Memo No 647-ISS/2M 22/2020 dtd. 15/05/2021 in consonance with order promulgated by Govt. or West Bengal vide Memo No 486-CS/2021 dtd. 24/04/2021 following with the cider of close, or West Bengal vide Memo No-707-ISS/2M-22/20 dtd. 29.05.21. Consequently, the supra noted persons were arrested on the spot and informed them the ground of their arrest and issued memo of arrest in respect of them.

As the supra noted persons violated the order and disobeyed the direction during this pandemic situation duly promulgated by Govt. of West Bengal vide Memo No 647-ISS/2M-22/2020 dtd. 15/05/2021 in consonance with order promulgated by Govt. of West Bengal vide Memo No 486-CS/2021 dtd. 24/04/2021 following with the order of Govie of West Bengal vide Memo No-707-ISS/2M-22/20 dtd. 29.05.21 so they can be booked U/S 188/34 of the IPC and read with section 51 of the National Disaster Management Act 2005. So a specific case may kindly be initiated against them and arranged for its investigation.
