In producing herewith the 06 (Six) persons namely i) Ayub Ansary (34) s/o Lt. Muhammad Ansary of Vill- Sindri, PS- Purulia (M), Dist- Purulia, A/P Chas Morh under Purulia (M) PS, Dist- Purulia, ii) Karam Chand Jogi (25) s/o Dilip Jogi of Vill- Bamundiha, PS - Arsha, Dist-Purulia, iii) Baidynath Mahato (28) s/o Durga Charan Mahato of Vill- Amdiha, PS- Chandankeyary, Dist- Bokharo, Jkd. iv) Abani Kumar (35) s/o Renghu Kumar of Barabondya, PS- Joypur, Dist- Purulia, v) Rulchand Mahato (32 yrs) s/o Gorachand Mahato of Vill- Dhabani, PS- Joypur, Dist- Purulia, vi) Bijoy Paramanik (47 yrs) s/o Biswanath Paramanik of Vill- Palanza, PS-Joypur, Dist- Purulia.

The fact of the case in a nut shell is that I SI Nitish Goswami along with force namely i) C/235 Ramchandra Gorain, ii) C/692 Ukil Ch. Gorain & iii) C/809 Madhusudhan Mahato of Purulia (M) PS performing the Mobile duty for the implementation of partial Lock Down in the area vide Purulia (M) PS GDE No 537 dtd. 11.08.2021 in consonance with C C No 2273/21 Dtd. 11.08.2021 as per order of superior. During my Mobile Duty, while I arrived at Surulia Morh at 20:15 hrs. and found 06 (five) persons noted in the supra were confabulating among themselves sitting beside the road without wearing the mask and maintaining the social distance at the partial lock down in all over the state. On being asked they could not give sufficient reason or satisfactory answer of their unwarranted confabulation beside the road after violating the Government order in this pandemic situation. Consequently, it reasoned to believe that they violated the order and disobeyed the direction during this pandemic situation duly promulgated by Govt. of West Bengal vide Memo No 647-ISS/2M-22/2020 dtd. 15/05/2021 in consonance with order promulgated by Govt. of West Bengal vide Memo No 486-CS/2021 dtd. 24/04/2021 following with the order of Govt. of West Bengal vide Memo No-707-ISS/2M-22/20 dtd. 29.05.21. Consequently, the supra noted persons were arrested on the spot and informed them the ground of their arrest and issued notice of arrest in respect of them.

As the supra noted persons violated the order and disobeyed the direction during this pandemic situation duly promulgated by Govt. of West Bengal vide Memo No 647-ISS/2M-22/2020 dtd. 15/05/2021 in consonance with order promulgated by Govt. of West Bengal vide Memo No 486-CS/2021 dtd. 24/04/2021 following with the order of Govt. of West Bengal vide Memo No-707-ISS/2M-22/20 dtd. 29.05.21 so they can be booked U/S 188/34 of the IPC and read with section 51 of the National Disaster Management Act 2005. So a specific case may kindly be initiated against them and arranged for its investigation.
