In producing herewith one seized vehicle (Tractor, model Powertrac-434 Plus colour-Blue) bearing Engine No- E3589440 & Chassis No.-T053524368KK attached with its loaded Sand Trolley and with proper Seizure list.

The nub of the fact in a nutshell is that on 20.08.2021 at 08.45 hrs while myself along with force 1) C/297 Apurba Pandey, 2) NVF/969 Pralay Mahato all of Purulia (M) PS left the PS for performing Day mobile duty vide Purulia (M) PS CC No 2359/2021 and GDE No 898 Dt. 20.08.2021 in PS area. During my day mobile duty, I received a tip off at 17:25 hrs that one tractor driver & its owner were lifting sand illegally from Kasai river and said suspicious tractor loaded with sand was coming from Belkuri Sadhu Ashram morh towards Shibdih more. Subsequently, I along with force proceeded towards Shibdih more to work out the tip off. While I along with force arrived at Shibdih near Railway X-ing and found that 01 (one) tractor was proceeding towards Shibdih more along by pass road. on being see the police party from far away, the driver of the said vehicle (Tractor) stooped the tractor & fled away to avoid the any touch of police. I along with force also chased the driver to detain but could not. Then I along with force intercepted the vehicle (Tractor, model- Powertrac-434 Plus colour-Blue) bearing Engine No- E3589440 & Chassis No.-T053524368KK attached with its Trolley loaded with Sand at 18:45 hrs and I found the vehicle as well as goods as identical as I received prior information. I also informed the matter to my I/C Purulia (M) PS and as per his kind direction, I along with force were awaiting long time but none could turn up before me. It was ascertained that the driver of the those tractor loaded the said sand in cahoots with the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and he have been running a clandestine business. So it is reasoned to belief that driver of the said vehicle in cahoots with the owner of the vehicle procured the said sand form Kansai River near Bhul ghat by fraudulently means or theft by any means for transporting the same to run clandestine business. So I, seized the (tractor, model-Powertrac-434 Plus colour-Blue) bearing Engine No- E3589440 & Chassis No.-T053524368KK attached with Trolley loaded with Sand approx. 100 CFT under proper seizure. Thereafter, I brought the seized tractor to Purulia (M) PS compound as per kind direction of I/C Purulia (M) PS.

Under the above facts and circumstances kindly take lawful action against the drivers as well as owner of the vehicle (Tractor, model- Powertrac-434 Plus colour-Blue) bearing Engine No-E3589440 & Chassis No.-T053524368KK.
