In producing herewith the driver namely Sahan Rajwar (22 yrs) S/O Sankar Rajwar of Vill- Lagda, PS- Purulia (M), Dist- Purulia along with seized vehicle (Tractor) Model -Mahidra B 275DI, Bearing Reg. No. WB55A/6904, Engine No- RHH2EAN7579 & Chassis No.-MBNABAEXPHRH03686 attached with loaded Sand Trolley and with Seizure list, Memo of Arrest and Inspection Memo in respect of the supra persons before you.

The nub of the fact in a nutshell is that on 24.08.2021 at 17:15 hrs while I along with force 1) NVF/726 Anup Bhagat, 2) NVF/363 Hemanta Kumar 3) HG/1618 Haripada Gorain all of Purulia (M) PS left the PS for performing Evening mobile duty vide Purulia (M) PS CC No 2411/2021 and GDE No 1101 Dt. 24.08.2021 in PS area. During my evening mobile duty, I received a tip off at 19:15 hrs that a suspicious tractor loaded with sand was coming from Sindri Chasmore towards Imundih more. Subsequently, I along with force proceeded towards Imundih more to work out the tip off. While I along with force arrived at Imundih more found that 01 (one) tractor was proceeding towards Imundih more along Purulia- Ranchi road. I along with force intercepted the vehicle (Tractor) Model -Mahidra B 275DI, Bearing Reg. No. WB55A/6904, Engine No- RHH2EAN7579 & Chassis No.-MBNABAEXPHRH03686 attached with Trolley loaded with Sand at 19:45 hrs and I found the vehicle as well as goods as identical as I received prior information. On being asked, the driver of the said vehicle disclosed his name noted in the supra. I asked the driver of the vehicle to produce the valid documents in respect of the vehicle as well as the loaded sand. But the drivers of the said vehicle could not able to produce any kind of documents in respect of the Tractor and the sand. I repeatedly asked the driver to produce the valid paper but he stated differently in different times. The incoherent statement of the driver purported to be a suspicious to us. It was ascertained that the driver of the those tractor loaded the said sand in cahoots with the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and he have been running a clandestine business. So it is reasoned to belief that he in cahoots with the owner of the vehicle procured the said sand form Kansai River near Kantabera village side by fraudulently means or theft by any means for transporting the same to run clandestine business. So I, seized the (tractor) Model - Mahidra B 275DI, Bearing Reg. No. WB55A/6904, Engine No- RHH2EAN7579 & Chassis No.-MBNABAEXPHRH03686 attached with Trolley loaded with Sand (approx. 100 CFT) under proper seizure list in presence of available witnesses duly signed by him and also arrested the driver namely Sahan Rajwar (22 yrs) S/O Sankar Rajwar of Vill- Lagda, PS- Purulia (M), Dist- Purulia after informing the ground of his arrest and issued Memo of Arrest and Inspection Memo against him. Thereafter, I brought the seized tractor attached with sand loaded trolley to Purulia (M) PS compound.

Under the above facts and circumstances kindly take lawful action against and the drivers namely Sahan Rajwar (22 yrs) S/O Sankar Rajwar of Vill- Lagda, PS- Purulia (M), Dist-Purulia of the vehicle as he committed offence u/s 379/411/414 of the IPC & 21(1) (4) of Mines and Minerals (R&D) Act-1957.
