Sir,

In producing herewith one arrested accd. person namely Tufan Dey (31 Yrs) s/o Lt. Dulal Dey of Vill- Joynagar, PO- Hutmura, PS- Purulia (M), Dist- Purulia with seizure list and seized articles.

I beg to submit that today (27.08.2021) while I was detailed to perform mobile duty in PS area along with force i) C/967 Basudeb Sing Mura, ii) NVF/0068 Mahanta Mahato & iii) NVF/ 927 Anup Kr. Bhagat all of Purulia (M) PS & Purulia (M) PS C.C. No 2449/21 Dt. 27.08.2021 and GDE No 1239 Dtd. 27.08.2021. During my mobile duty, I received a secret tip off that an illegal possession of huge amount of Country spirit. Subsequently, I informed you and as per your direction, I rushed to the spot that is Gobradih Tola under Mamurjorh village and after arriving at the spot and as per instruction conducted raid in that area under this PS at 18:45 hrs. During the raid 2/3 persons fled away near the pushcart and detained one person. On asking the identity he disclosed his name address as noted supra. On interrogation he confessed that he possessed the Country spirit for selling illegally from his wheelbarrow so that he could gain more amount from the selling of (liquors) Country Spirit. On demand he failed to produce any valid document in respect of selling and possession of said (liquors) Country Spirit at his house. Subsequently, I seized **50 (fifty) sealed bottles liquors of country sprite each containing 300 ml., MRP 25/- per bottles which is styles as "Dil Khush" and kept 01 sealed bottles as sample from 50 (fifty) bottles** under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. Consequently, I arrested the above noted accused person after informing him the ground of arrest and issued Memo of Arrest and observed all legal formalities in respect of the Arrest. The seized articles were properly sealed and labeled in presence of witnesses duly signed by them and accused person.

The above noted arrested person Namely Bibhuti Barui (57 yrs) s/o Lt. Aruni Bauri of Gobradih Tola under Mamurjorh village, PS- Purulia (M), Dist- Purulia committed offence U/S 46 A (c) of Bengal Excise Act. 1909 for unauthorized possession for selling of Country Spirit from his wheelbarrow. Under the fact and circumstance kindly take necessary lawful action against Bibhuti Barui (57 yrs) s/o Lt. Aruni Bauri of Gobradih Tola under Mamurjorh village, PS- Purulia (M), Dist- Purulia.
