Enquiry report regarding fraudulent appointment of Apurba Mukherjee s/o Debasish Sub: Mukherjee of vill-Ajodhya Hill Top, PS Baghmundi, Dist Purulia.

Letter No.415/5M-23 dtd.08.02.2021, 1432/5M-23 dtd.04.05.2021 and 1489/5M-23 Ref .: dtd.07.05.2021 of DFO, Purulia Division.

Respected Sir,

With due respect I would like to inform you that an enquiry report against fraudulent appointment of Apurba Mukherjee s/o Debasish Mukherjee of vill-Ajodhya Hill Top, PS Baghmundi, Dist Purulia was endorsed to me to examine the forged ID holder. I tried to examine said Apurba Mukherjee but he was out of station due to searching of job. I contacted DFO office to send a fresh letter with additional information about Apurba Mukherjee if any by adding name with designation of DFO, Purulia division as directed from your end. On 05.05.2021 I received the letter No. 1432/5M-23 dtd.04.05.2021 endorsed from your end vide No.R/1644/ \vee 23 dtd.08.02.2021, but no additional information by adding name with designation of DFO, Purulia division has been given. Again as per your direction I contacted with the DFO, Purulia Division office. On 26.07.2021 I received a letter No. 1489/5M-23 dtd.07.05.2021 with name and designation of DFO, Purulia Division endorsed from your end vide No. R/2432/V dtd.26.07.2021.

On 29.07.2021 I again contacted with Apurba Mukherjee s/o Debasish Mukherjee of vill-Ajodhya Hill Top, PS Baghmundi, Dist Purulia and examine him. It is come to light that he has been forged by one Amit Sen of Purulia. Amit Sen informed him about forest guard service in February'2020 and he offered job of forest guard in lieu of Rs.3.5 lakh. Amit Sen provided him an appointment letter through e-mail wbforestsec.gov.in@gmail.com and an ID card. He paid Rs.3.5 lakhs to Amit Sen on different dates. Later he was informed to contact one Raja Chatterjee for joining and he was taken to Pirakata Range office, Medinipur for joining. He was kept in a nearby hotel for almost one month and he was taken to forest in the name of doing duty as forest guard. He returned from Medinipur to Purulia on 25.12.2020 by realizing that he had been duped by those persons. In the meantime he tried to contact with Amit Sen and Raja Chatterjee but they did not respond. He did not lodge any complaint against them so far.
