During the time of inspection, it was observed that accused Nurul Haque(Present user) under Purulia CCC; has made unauthorized use of electricity by tampering of electric energy meter by inserting foreign particle (resister) where electricity energy consumption comes to near about zero and hence causing huge loss of revenue to WBSEDCL.
