Subject: Forced Entry by Unidentified Miscreants into GAIL Installation (IP-06) (Intermediate Pigging Station) at Dandua Village, Raghunathpur Thana, Purulia District.

Dear Sir,

As aware that GAIL (India) Ltd. has laid and operating cross country pipeline named JHBDPL from Phulpur (UP) to Haldia (W.B.) and associated Spur pipelines in West Bengal.

The Gas pipeline has been commissioned on 07th February 2021 from Dobhi – Durgapur and Natural Gas is being supplied to MatixFertiliser, Durgapur (Panagarh). "Intermediate Pigging Station (IP-06)" is to facilitate the Pigging activities and other related maintenance activities of the pipeline. We will start the process of declaring IP – 06 as Prohibited Area. Since installation is highly hazardous and value of high importance for supplying natural gas to fertilizer plant, City Gas distribution of Purulia District and earning revenue to West Bengal.


On intervening night, 31st July – 01 August 2021 at around 0140 Hrs. some unknown unidentified miscreants, face covered with clothes, having axe, sword, iron rod etc. forcefully entered the GAIL Installation and broken the lock. They ransacked Security Guard Glass door and damaged the LED lights installed at the main gate and stolen away cable worth around Rs. 10,000/15,000.


Therefore I pray before your necessary action may kindly be taken from your end.
