Sub: Request for lodging FIR against arrested accused persons.

Sir,

With due respect I beg to submit before you that on 08/08/2021 at about 11:05 PM while I, SI Indrajit Sarkar along with force vide CC No 2077/21 dated- 08.08.2021 were engaged on night mobile duty in Raghunathpur Town area and found the following persons were moving at Raghunathpur Traffic more aimlessly and not wearing mask in this pandemic situation and violation of social distancing, as such I detained them on that spot. On being asked the following persons could not able to give any satisfactory answer for that moving aimlessly without mask in this pandemic situation and violation of social distancing. As such the following persons violated the order during the pandemic situation duly promulgated by Govt. of WB in c/w Corona virus/Covid-19 vide No. 753/III-ISS/2M-22/2020 dated- 14.07.2021 and they are responsible for their negligent Act and malignant Act likely to spread infection of disease dangerous to life. Moreover, all the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society. Accordingly the following persons were arrested after maintaining all the formalities regarding their arrest and brought them to PS.

- 4) Avijeet Kumar Tiwari (35) S/o Murari Tiwari of Sankarsahi Road No. 5, Janta Path, Dimna Road, Mango PS, Dist.- East Singhbhum, Jharkhand.
- 5) Deenbandhu Kaibartha (25) S/o Anadi Kaibartha of Vill.+PO – Basuhatu, PS – Ishagarh, Dist.- Saraikella – Kharswan, Jharkhand.
- 6) Rohit Sahay (28) S/o Sunil Kumar Sahay of House No. 33, Vidyapatnagar, Baridih, Near Eng. College, PS – Sidhgora, Dist.- East Singhbhum, Jharkhand.
