Sub : Prayer for lodging FIR against accused Dhumbal Modak (47,) S/O - Bhutnath Modak of Kanki (Beko colony), Hat tola, PS-Santaldih, Dist- Purulia U/S 46A (c) B.E. Act 1909.

Sir,

I am producing herewith arrested accused named as Dhumbal Modak (47), S/O - Bhutnath Modak of Kanki (Beko colony), Hat tola, PS-Santaldih, Dist- Purulia along with seizure - list and seized items as described below, I beg to state that on 27.08.2021 at about 18.25 hrs I received a source information to the effect that the country spirit (Dil khush) has been kept at Kanki (Beko colony), Hattola in the house of above noted accused illegally with an object to sale. I have diarized the information vide Santaldih PS GDE No- 921, dated 27.08.2021 and also informed the matter to I.C. Santaldih PS and as per order of I.C Santaldih P.S. I along with force left for Kanki (Beko colony) to workout the information with the govt. supplied kits box containing white cloth, sealing wax, seal, papers, carbons, match box, candles etc. I had been to the house of Dhumbal Modak at Kanki (Beko colony), Hat tola, P.S. Santaldih at about 18.35 hours. Seeing police party some unknown persons in front of the house of Dhumbal Modak fled away. However, I could detain one among them and asked about his identity. He revealed his name and identify as above and as well as informed also that he gather the country spirit (Dil khush) for selling and he was the owner of the said house. However, I along with said accused started a search inside the house of Dhumbal Modak and found the following item in the said house.

- 1) 18 (Eighteen) bottles 80UP country spirit (Dil khush) each bottles containing 600 ML market value of each being in total approx Rs. 900/ - (Nine hundred only)
01 (one) bottle of 600 ML taken (Dil khush) out of the above as sample packet, labeled and sealed with sealing wax.
- 2) Sale Proceed cash of Rs.- 155/- (One hundred fifty five only)

I interrogated him about the purpose of the stocking and possessing country spirit. He replied it was the business of him. On repeated question he told that the persons who fled away were his customers (names of those not known to him). However he could not show any documents/papers in support of the possession as well as sale of the said articles.

As such, I seized the above items as ALAMAT under proper Seizure List between 18.45 hrs and 19.10 hrs & took up one bottle of each brand as samples, labeled and sealed accordingly.

Since the allegation against him of possessing, as well as selling the country spirit illegally without any valid papers in his house has prima-facie been made out and for the interest of proper investigation. I arrested the above accused at 19.15 hrs accordingly.

Therefore, I pray before you to start a case under proper section of law against the said accused Dhumbal Modak (47 yrs) S/O - Bhutnath Modak of Kanki (Beko colony), Hat tola, PS-Santaldih Dist- Purulia.
