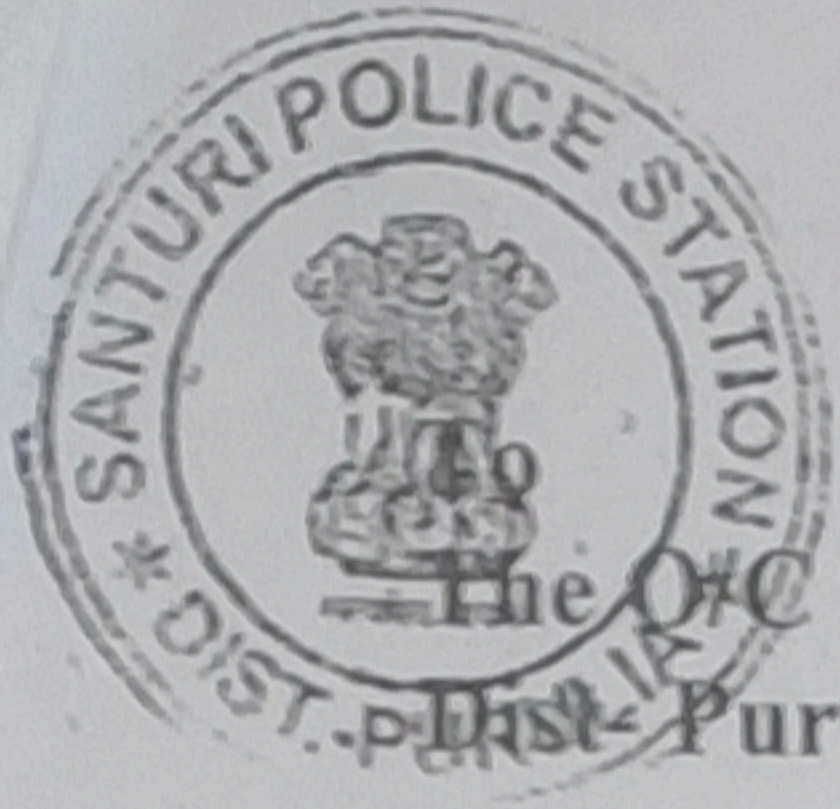

I, SI Subrata Patra S/O Shri Bimal Patra of Vill. Ishabpur, P.S Belda, Dist. Paschim Medinipur do here by produce 07 (Seven) arrested accused persons namely (1) Gouranga Bauri (38Yrs), S/O- Lt. Sushil Bauri, Vill- Sunuri, PS- Santuri (2) Kamal Ghosh (45Yrs), S/O- Lt. Bhandu Ghosh, Vill- Madhukunda, PS-Santuri (3) Binod Karmakar (33Yrs) S/O- Lt. Bhandu Karmakar, Vill- Pradiha, PS-Santuri (4) Rakesh Sahis (23 Yrs) S/O- Bablu Sahis, A/P- Raghunathpur word No-01, PS-Raghunathpur (5) Kripasindhu Tantubay (28 Yrs) S/O- Lt. Bholanath Tantubay, A/P- Raghunathpur ward No-12, PS-Raghunathpur (6) Prakash Bauri (38 yrs), S/O-Lt. Manjura Bauri, Vill- Chelyamam PS-Raghunathpur all are Dist- Purulia (7) Santa Pal (30 Yrs), S/O- Nepal Pal, Vill- Bhaluka, PS- Saltora Dist-Bankura & do hereby lodge a written complaint against them, to the effect that today on 04.08.2021 while I along with C/1193 Manaranjan Bhui & C/702 Anal Kanti Banerjee of Santuri PS as per direction engaged in mobile duty within Santuri PS area, (Reference Santuri P.S G.D.E No. 157 dtd. 04.08.2021) for implementation of Government rules regarding Disaster Management Plan. On 04.08.2021 while we were returning from Jagannathdih side under Santuri P.S jurisdiction and reached at Jagannathdih More at about 20:45 hrs. found that the above noted 07 (Seven) persons were gossiping near Jagannathdih More without wearing a mask and no maintaining social distancing which violates the compliance of norms of wearing of mask and maintaining social distancing during this pandemic situation in c/w COVID-19. So, there is every reason to believe that the above noted persons were moving without wearing a mask and no maintaining social distancing which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule (Memo No. 647-ISS/2M-22/2020 Dated- 15th May 2021 Government of West Bengal 'Nabanna' 325, Sarat Chatterjee Road Howrah- 71102). So, I have arrested them maintaining all legal formalities as well as notifying the ground of arrest and informed their family members through local people.

Therefore, I pray a specific case may kindly be started against accused persons (1) Gouranga Bauri (38Yrs), S/O- Lt. Sushil Bauri, Vill- Sunuri, PS- Santuri (2) Kamal Ghosh (45Yrs), S/O- Lt. Bhandu Ghosh, Vill- Madhukunda, PS-Santuri (3) Binod Karmakar (33Yrs) S/O- Lt. Bhandu Karmakar, Vill- Pradiha, PS-Santuri (4) Rakesh Sahis (23 Yrs) S/O- Bablu Sahis, A/P- Raghunathpur word No-01, PS-Raghunathpur (5) Kripasindhu Tantubay (28 Yrs) S/O- Lt. Bholanath Tantubay, A/P- Raghunathpur ward No-12, PS-Raghunathpur (6) Prakash Bauri (38 yrs), S/O-Lt. Manjura Bauri, Vill- Chelyamam PS-Raghunathpur all are Dist- Purulia (7) Santa Pal (30 Yrs), S/O- Nepal Pal, Vill- Bhaluka, PS- Saltora Dist-Bankura under proper sec. of law as they disobeyed/ignored Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Government rule and arrange for its investigation.
