Respected Sir,

I, PSI Mrinmay Bhakta, S/O – Swapan Kr. Bhakta of Vill.- Tantipara, P.S:- Chandrapur, Dist.- Birbhum at present posted as PSI of Police at Santuri PS, Dist.- Purulia do here by produce 03 (Three) arrested accused persons namely (1) Bijoy Mahali (20 Yrs), S/O- Lakhu Mahali, (2) Dashrath Mahali (22 Yrs), S/O- Lakhu Mahali both are Vill.- Kalipahari (3) Kalidas Murmu (27 Yrs) S/O- Rabilal Murmu, Vill- Gumra all are PS-Santuri, Dist.- Purulia & do hereby lodge a written complaint against them, to the effect that today on 14.08.2021 while I along with C/2930 Aniruddha Patra & C/2696 Subal Mahato of Santuri PS as per direction engaged in mobile duty within Santuri PS area, (Reference Santuri P.S C.C. No. 2648, dtd. 14.08.2021) for implementation of Government rules regarding Disaster Management Plan. On 14.08.2021 while we were returning from Marbedia side under Santuri P.S jurisdiction and reached at Marbedia More at about 21:15 hrs. found that the above noted 03 (Three) persons were gossiping near Marbedia More without wearing a mask and no maintaining social distancing which violates the compliance of norms of wearing of mask and maintaining social distancing during this pandemic situation in c/w COVID-19. So, there is every reason to believe that the above noted persons were moving without wearing a mask and no maintaining social distancing which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule (Memo No. 647-ISS/2M-22/2020 Dated- 15th May 2021 Government of West Bengal ‘Nabanna’ 325, Sarat Chatterjee Road Howrah- 711102). So, I have arrested them maintaining all legal formalities as well as notifying the ground of arrest and informed their family members through local people.

Therefore, I pray a specific case may kindly be started against accused persons (1) Bijoy Mahali (20 Yrs), S/O- Lakhu Mahali, (2) Dashrath Mahali (22 Yrs), S/O- Lakhu Mahali both are Vill.- Kalipahari (3) Kalidas Murmu (27 Yrs) S/O- Rabilal Murmu, Vill- Gumra all are PS-Santuri, Dist.- Purulia under proper sec. of law as they disobeyed/ignored Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Government rule and arrange for its investigation.
