I, SI Santosh Roy S/O- Lt. Suraj Nath Roy of Vill.- Dishergarh, P.S - Kulti, Dist- Paschim Burdwan do here by produce 08 (Eight) arrested accused persons namely (1) Dhananjoy Murmu (24 yrs), S/O-Lt. Budheswar Murmu, Vill- Gumra (2) Sk. Sarfudin (35 Yrs) S/O- Sk Ismaile, Vill- Murulia (3) Rabilal Soren (32 Yrs) S/O- Lt. Kalicharan Soren, Vill- Dumdumi all are PS-Santuri, Dist- Purulia (4) Durgadas Gorain (30 Yrs) S/O- Raghunath Gorain, Vill- Kolakuri (5) Kajal Gorain (28 Yrs), S/O- Dhirendranath Gorain, Vill- Kolakuri (6) Sukesh Gorain (32 Yrs), S/O- Durgadas Gorain, Vill- Kolakuri (7) Sukhesh Mondal (31 Yrs), S/O- Sankar Mondal, Vill- Kolakuri (8) Sanjoy Adhikari (28 Yrs), S/O- Tapan Adhikari, Vill- Pabra all are PS-Saltora, Dist- Bankura & do hereby lodge a written complaint against them, to the effect that today on 01.08.2021 while I along with C/863 Rupchan Pauria & NVF/809 Indrajit Paramanik of Santuri PS as per direction engaged in mobile duty within Santuri PS area, (Reference Santuri P.S G.D.E No. 33 dtd. 01.08.2021) for implementation of Government rules regarding Disaster Management Plan. On 01.08.2021 while we were returning from Marbedia side under Santuri P.S jurisdiction and reached at Hansdima More at about 21:35 hrs. found that the above noted 08 (Eight) persons were gossiping near Hansdima More without wearing a mask and no maintaining social distancing which violates the compliance of norms of wearing of mask and maintaining social distancing during this pandemic situation in c/w COVID-19. So, there is every reason to believe that the above noted persons were moving without wearing a mask and no maintaining social distancing which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule (Memo No. 647-ISS/2M-22/2020 Dated- 15th May 2021 Government of West Bengal 'Nabanna' 325, Sarat Chatterjee Road Howrah- 711102). So, I have arrested them maintaining all legal formalities as well as notifying the ground of arrest and informed their family members through local people.

Therefore, I pray a specific case may kindly be started against accused persons (1) Dhananjoy Murmu (24 yrs), S/O-Lt. Budheswar Murmu, Vill- Gumra (2) Sk. Sarfudin (35 Yrs) S/O- Sk Ismaile, Vill- Murulia (3) Rabilal Soren (32 Yrs) S/O- Lt. Kalicharan Soren, Vill- Dumdumi all are PS-Santuri, Dist- Purulia (4) Durgadas Gorain (30 Yrs) S/O- Raghunath Gorain, Vill- Kolakuri (5) Kajal Gorain (28 Yrs), S/O- Dhirendranath Gorain, Vill- Kolakuri (6) Sukesh Gorain (32 Yrs), S/O- Durgadas Gorain, Vill- Kolakuri (7) Sukhesh Mondal (31 Yrs), S/O- Sankar Mondal, Vill- Kolakuri (8) Sanjoy Adhikari (28 Yrs), S/O- Tapan Adhikari, Vill- Pabra all are PS- Saltora, Dist- Bankura under proper sec. of law as they disobeyed/ignored Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Government rule and arrange for its investigation.
