Respected Sir,

In producing herewith one arrested accused person namely Sankar Mahato (36 yrs) S/O- Madhu Mahato of Vill- Gurpa, P.S- Tamna, Dist.- Purulia with seizure list and seized articles. I beg to submit that today i.e. on 27.08.2021 at about 18:35 hrs during special mobile duty, received a secret source information and as per order of O/C Tamna PS, I SI Hemanta Kumar Sahababu of Tamna PS along with force had been to Gurpa village under Tamna PS at 19:15 hrs and as per indication conducted raid in the house of Sankar Mahato (36 yrs) S/O- Madhu Mahato of Vill- Gurpa, P.S- Tamna, Dist - Purulia and found 2/3 persons fled away from his house and detained one person. On asking his identity he disclosed his identity as noted above. On interrogation he confessed his guilt for selling and possession of ID Liquor. On demand he failed to produce any valid documents in respect of stock and selling of said ID Liquor at his own house. As such I seized three (03) white colour Jariken wherein 24 Ltrs. ID Liquor in to the said Jariken. One bottles taken from ID Liquor of 1 litter as sample under proper Seizure List in presence of witnesses duly signed by witnesses and accused person. Arrested the above noted accused person after observing all legal formalities regarding arrest. Informed him the ground of his arrest. The seized articles was properly sealed and label in presence of witnesses duly signed by them and accused person.

The above noted accused person namely Sankar Mahato (36 yrs) S/O- Madhu Mahato of Vill- Gurpa, P.S- Tamna, Dist.- Purulia committed offence u/s- 46 A(c) B.I. Act- 1909 for unauthorized possession and sales of ID Liquor from his house.

Under the fact and circumstances kindly take necessary lawful action against Sankar Mahato (36 yrs) S/O- Madhu Mahato of Vill- Gurpa, P.S- Tamna, Dist - Purulia
