(Reference Tamna P S G.D.F No 80 dtd. 02.08.2021) for implementation of Government rules of Disaster Management Plan reached at Simulia More under Tamna PS at about 20:45 hrs and found that the above noted 13 (Eight) persons were gossiping without wearing mask and not maintaining physical distancing which violates the compliance of norms of wearing of mask and maintaining physical distancing during this pandemic situation in c/w COVID-19. So, there is every reason to believe that the above noted persons were moving without wearing mask and not maintaining physical distancing which violates the compliance of norms of Govt. of India as well as Govt. of West Bengal during this pandemic situation and committed negligent act likely to spread infection of diseases which dangerous to life. So, I have arrested them maintaining all legal formalities as well as notifying the ground of their arrest
