I. PSI Surajit Kr. Das, S/O- Samir Kr. Das of Tamna. PS. Dist- Purulia. I do hereby produced one Sunil Mahato (48 Yrs) S/O- Braiakishore Mahato of village- Manguria. PS-Tamna. Dist- Purulia hereby lodge a complaint, to the effect that on 02.08 2021 while myself along with force of Tamna PS as per direction engaged in Night Mobile duty within Tamna PS area. (Reference Tamna PS G D.F. No. 94 dtd. 02.08.2021) for implementation of Government rules of Disaster Management Plan reached at near Manguria turning beside NII- 32 in front of Sonalica Tractor Show Room under Tamna PS at about 23-30 hrs. and found that the 5-6 persons were gossiping without wearing mask and not maintaining physical distancing which violates the compliance of norms of wearing of mask and maintaining physical distancing during this pandemic situation in c/w COVID-19. So, there is every reason to believe that the above noted persons were moving without wearing mask and not maintaining physical distancing which violates the compliance of norms of Govt of India as well as Govt of West Bengai during this pandemic situation and committed negligent act likely to spread infection of diseases which dangerous to life

On seeing police party they started running, after a hot chase we managed to arrest 2 persons of being asked, they disclosed their identity as (1) Deep Bauri (26 Yrs) S/O- Mathur Bauri of village- Manguria, PS- Tamna, Dist- Purulia, (2) Sunil Mahato (48 Yrs) S/O- Brajakishore Mahato of village- Manguria, PS- Tamna, Dist- Purulia, while the rest fled away

So. I have arrested above noted two persons maintaining all legal formalities as well as notifying them the ground of their arrest.

I like to note here that on way to P.S one of the arrested Deep Bouri who was in police Jeep(WB56C 8742) sunndenly jumped from the jeep near Progati Cement Factory on Willcox road. He received bleeding injuries. Then we took him in our Jeep and shifted him to Deben Mahato Govt hospital for treatment also informed his relatives. Later he was reterred to Bankura Medical College for better treatment.

Therefore I request that a specific case may kindly be started under proper section of law against above noted Sunil Mahato. Deep Bauri and '4 others
