Sir,

In producing here with one arrested accused namely Binod Ram Khatik (50 Yrs) S/O Lt. Bodhi Ram Khatik of Vill- Gayadih, PS-Adra, Dist- Purulia along with following seized articles with seizure list and Memo of Arrest.

1) 16 bottles DIL KHUSH country spirit, 600 Ml. each Rs/-50 of each bottle.

I PLSI Iti Neogi of Adra PS do here by lodged a complaint against accused namely Binod Ram Khatik (50 Yrs) S/O Lt. Bodhi Ram Khatik of Vill-Gayadih, PS-Adra, Dist- Purulia to the effect that on 16/09/21 at about 05:45 hrs I received a information from a reliable source that one Binod Ram Khatik has been stock of country spirit illegally at his Shop at Gayadih. After getting such information I informed to my I/C and as per his direction I along with my accompanied force left Adra PS vide Adra PS CC No-3430/21 dtd.15.08.21. I reached at Gayadih Adra at about 05:55 hrs on 16.09.2021 and hold raid in the Shop of said Binod Ram Khatik and found that the said person selling liquor at his house/shop and after seeing the Police party some person fled away and said Binod Ram Khatik has tried to concealed himself but I able to apprehend him with the help of accompanied force and also detained him. I asked him to produced valid License or valid papers for selling country spirit but he failed to produce any valid license or documents for possessing /selling the same. So it is sufficient reason to believe that said Binod Ram Khatik selling the country spirit by illegal way. I seized the above mentioned articles under proper seizure list duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest. The complete process was done in between 06.05 hrs to 06.25 hrs.

Hence I there for pray that a specific case may kindly be started against arrested accused Binod Ram Khatik (50 Yrs) S/O Lt. Bodhi Ram Khatik of Vill-Gayadih, PS-Adra, Dist- Purulia under proper section of law.
