I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Biswajit Mishra S/O- Lt. Kiritibhushan Mishra of Village- ChaKolta P.O- Adra,

P.S- Adra Dist-PURULIA has committed theft of Electricity U/S-135 of the Electricity (Amendment) Act-2007.

On dated 16.09.2021 at about 1:15 P.M, Sri Aniruddha Ghosh, Station Manager, Adra Customer Care Centre, WBSEDCL along with,

Entered the premises of Biswajit Mishra S.O- Lt Kiritibhushan Mishra of Village- ChaKolta P.O- Adra P.S- Adra Dist-Purulia and inspected his premises.

During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by drawing of electric power through by-passing from incoming Service Cable before Energy meter. Supply i.e. U/S 135 was detected.

From the above system he/she was using the following Electrical equipments i.e.

- 1) 5 Fans = 300 watt 2) 1 TV = 200 watt 3) 1 Fridge = 180 watt
4) 2 Tube light = 40 watt 5) 5 L.E.D Lamps = 45 watt

Out of which we seized the following: The complete by pass arrangement before energy meter, which includes 5 mtr of 2 core insulated PVC wire with hooking arrangement.

The seizure lists are prepared at the site and the accused person signed in the seizer list

The inspection team left the above premises at about 1:45 P.M on dated 16.09.21. The accused person has committed an offence U/S-135(i)(b) of the Electricity (Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per Rule.
