P.S- Adra, Dist-PURULIA has committed theft of Electricity U/S-135 of the Electricity (Amendment) Act-2007.

On dated 16.09.2021 at about 2.20 PM I, Sri Aniruddha Ghosh, Station Manager, Adra Customer Care Centre, WBSEDCL along with,

Entered the premises of Md. Nasir, S.O- Lt. Md. Nausad of Village- Lower Jhariadih, P.O- Adra, P.S- Adra, Dist-Purulia and inspected his premises.

During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by Direct hooking from nearest LTOM line.

Supply i.e. U/S 135 was detected.

From the above system he/she was using the following Electrical equipments i.e.

- 1) 2 T.V = 200 watt.
- 2) 2 Fan = 120 watt.
- 3) 5 L.E.D Lamps = 45 watt.
- 4) 1 Fridge = 180 watt.

Out of which we seized the following: Approx 11 feet 2 core PVC cable with hooking device and switch board with switches.

The seizure lists are prepared at the site and the accused person signed in the seizer list

The inspection team left the above premises at about 2:40 PM on dated 16.09.2021. The accused person has committed an offence U/S-135(i)(a) of the Electricity (Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per Rule.
