Sir.

In producing herewith the arrested accused persons namely (1) Akram Raza (21 Yrs) S/O Md. Apish (2) Md. Sonu (22 Yrs) S/O Md. Shamim (3) Md. Sajjad Ansari (28 Yrs) S/O Md. Jabbar all are Vill-Chunabhati, PS-Adra, Dist- Purulia before you, along with seized articles like board money amounting to RS- 3080/-, 52 nos. of playing cards, from their possession etc. as per seizure list.

1 beg to report that on 16.09.2021 at 15:25 hrs, I received secret information that one gambling with huge amount was going on at abandoned room back side of Chunabhati Church during my special mobile duty. Accordingly I inform to I/C Adra PS and as per his direction I A.S.I Tanmoy Chatterjee along with (1) C/2182 Md. Safiul Khan (2) C/2389 Pinku Saha (3) C/ 3160 Ranjit Nayak vide C.C No-3442/21 in Govt, vehicles left for Chunabhati Village to work out the information. At about 15:45 hrs we reached at Chunabhati village and very slowly and cautiously approached towards back side of Chunabhati Church where the gambling was reportedly going on. From the outside of the abandoned room of the church we over heard the talking of persons present there and within a few moment it was clear that the persons present there were continuing gaming with playing cards in exchange of money causing wrongful loss to one and wrongful gain to another. After that I asked my associate staffs to cordon the place and within a moment the place was cordoned by Police party. We disclosed our identity and then some persons fled away but we were able to apprehend the above noted persons. Then, I requested them to search myself and my other staff accordingly the persons searched ourselves and found nothing except wearing apparels (Police Uniform with nameplates) and Mobile Phones. After that we asked their identity and the persons disclosed their name and address as noted above. It was found that a huge amount of currency note of different denomination were kept on gaming board (One white colour torn sack on the floor) and playing cards were also found. On demand the persons clearly confessed that all of them were doing gambling with playing cards in exchange of cash for wrongful less to one and wrongful gain to another. After that in presence of police party the board money of Rs 3080/- (Three Thousand eighty Rupees only) with different denomination, 52nos of Playing cards and One white colour torn sack were seized for the gaming board in between 15:55 hrs to 16:30 hrs under proper seizure list duly signed by police witnesses as the place is lonely so I found no public witness.

As such for committing offence punishable u/s- 3 & 4 of W.B.G & P.C Act all the above noted 03 (Three) persons were arrested, issuing arrest memo at 16.15 hrs to 16.30 hrs. After arrest I offered them medical treatment but they denied.

Therefore I pray before you that one specific case may kindly be start under proper section of law against the above noted accused persons & others and arrange for its investigation.
