Sir,

In producing here with one arrested accused namely Mukesh Verma (45 Yrs) S/O Lt. Om Prakash Verma of Panchudanga, PS-Adra, Dist- Purulia along with following seized articles with seizure list and Memo of Arrest.

1) 16 bottles DIL KHUSH country spirit, 600 Ml. each Rs/-50 of each bottle.

I SI Madan Chandra Supakar of Adra PS do here by lodged a complaint against accused namely Mukesh Verma (45 Yrs) S/O Lt. Om Prakash Verma of Panchudanga, PS-Adra, Dist- Purulia to the effect that on 24/09/21 at about 17:15 hrs I received a information from a reliable source that one Mukesh Verma has been stock of country spirit illegally at his Shop at Sabji Market Chaigada. After getting such information I informed to my I/C and as per his direction I along with my accompanied force left Adra PS vide Adra PS CC No-3550/21 dtd.24.09.21. I reached at Sabji Market Chaigada Adra at about 17:45 hrs and hold raid in the Shop of said Mukesh Verma and found that the said person selling liquor at his shop and after seeing the Police party some person fled away and said Mukesh Verma has tried to concealed himself but I able to apprehend him with the help of accompanied force and also detained him. I asked him to produced valid License or valid papers for selling country spirit but he failed to produce any valid license or documents for possessing /selling the same. So it is sufficient reason to believe that said Mukesh Verma selling the country spirit by illegal way. I seized the above mentioned articles under proper seizure list duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest. The complete process was done in between 17.55 hrs to 18.25 hrs.

Hence I there for pray that a specific case may kindly be started against arrested accused Mukesh Verma (45 Yrs) S/O Lt. Om Prakash Verma of Panchudanga, PS-Adra, Dist- Purulia under proper section of law.
