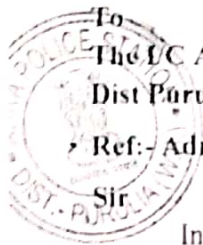

Sir,  
In producing herewith 02 (Two) accused persons namely (1) Shamim Ansary (40 Yrs), S/O-Md. Habibullah Ansary 2) Amanullah Ansary (29 yrs), S/O-Gul Mohammad both of Vill-Hesabatu, PO-Makhdumpur, PS-Balidih, Dist- Bokaro along with seized articles such as 1. One Iron Bhojali having wooden butt length 14.5 inch, 2. One black colour steel made folding knife having length 8.5 inch, (3) One Black & Red Colour Bajaj Pulsar Motor Cycle bearing Reg. No-JH 09AT/7147 as per seizure list.

I ASI Falguni Sarkar do hereby submit that today on (24.09.2021) at 21:45 hrs I/C Adra PS received source information that 07-08 persons were assembled at "Ludhar Dangar Bon" near Dubradih Bar and they were whispering about committing Dacoity in nearby Dubradih Village, with deadly weapon. As per order I/C Adra PS I along with officer and forces namely 1) ASI Krishnapada Gorain, 2) C/1272 Bikash Chandra Patra 3) NVF/903 Giridhari Mahato, all are of Adra PS vide C.C. No-3552/21, Dated- 24.09.2021 left for Ludhar Dangar Bon" near Dubradih Bar to work out the said information.

I along with force reached at "Ludhar Dangar Bon" near Dubradih Bar at 22:15 hrs by keeping the police vehicle at a distance of 200 meters away (approx), then we approached to the "Ludhar Dangar Bon" at an open space. We heard suspicious human voices at a distance from 25-30 meters to talking among themselves. I also found 07-08 persons were assembled there and after having heard and seen this I along with forces confronted suspicious character as police party and they tried to flee away from the spot. Above noted 02 persons tried to fled away by riding above seized motor cycle. During the hot chase they fell down from the Motor Cycle and received injury in their persons. On being asked they disclosed their identity as noted above. Accused Shamim Ansary received injury in both his hands and accused Amanullah Ansary receive injury in his right knee. Rest 04-05 persons fled away from the spot due to the darkness as well as geography of the locality. Then I offered the detained persons to search me and my Police party before searching their body, but they refused. After that we searched them. During search found 1. One Iron Bhojali having wooden butt length 14.5 inch recovered from the right pant pocket of Shamim Ansary. 2. One black colour steel made folding knife having length 8.5 inch recovered from the possession of Amanullah Ansary in his west back side in concealed by full pant and shirt, 3) One Black & Red Colour Bajaj Pulsar Motor Cycle bearing Reg. No-JH 09AT/7147. On interrogation the accused persons disclosed their names and address as noted above and confessed that they were assembled there for committing Dacoity at Dubradih village during this night. They also stated that they receive pain injury in the body parts where they has already pain injury from last 02 days ago. So, I arrested them informing the ground of arrest, observing all arresting guidelines and seized the above noted articles and labeled them duly signed by the police witnesses as there were no local witnesses available. As it was evident during our raid the accused persons assembled at a solitary place and were preparing amongst themselves with weapons found in their possessions for committing Dacoity at Dubradih village, actually committed an offence punishable U/S- 399/402 IPC. In view of this I arrested the above noted 02 (Two) accused persons and seized the weapons and other articles from their possession by preparing seizure list on the spot duly signed by the accused persons as well as police party and brought them to P.S. after their medical checkup at Raghunathpur SS/SD Hospital.

Hence I pray a specific case may kindly be started against (1) Shamim Ansary (40 Yrs), S/O-Md. Habibullah Ansary 2) Amanullah Ansary (29 yrs), S/O-Gul Mohammad both of Vill-Hesabatu, PO-Makhdumpur, PS-Balidih, Dist- Bokaro & other 4/5 unknown miscreants under proper section of law and arrange its investigation.
