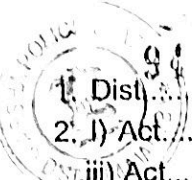

SUB: Complaint against offence u/s 21(1) of The Mines and Minerals (Development and Regulation) Act, 1957; Rule 3 of The WB Minerals (Prevention of illegal Mining, Transportation and Storage) Rules, 2002; Rule 50 of the West Bengal Minor Minerals Concession Rule 2016 .

Two vehicle bearing Registration No. WB 55A 8243 and WB 55A 5216 carrying 100 cft (Approximately) of sand has been intercepted by the undersigned on 09.09.2021 by 08-00 a.m., near B.D.O. office. The driver of the said vehicle failed to produce any lawful authority or valid transit pass to carry such mineral and fled away from the spot. Thus ,the Driver/Owner of the vehicle has violated the provisions of Section 4(1)/4(1A) of the Mines and Minerals (Development and Regulation) Act,1957, and liable to be prosecuted with imprisonment for a term which may extend upto two years or Rs one lakh or both ,in accordance with Sec.21(1) of the Mines and Minerals (Development and Regulation) act,1957, Rule 3 of the WB Minerals (Prevention of illegal Mining, Transportation and Storage) Rules, 2002; Rule 50 of the WB Minor Minerals Concession Rule 2016 and also under Section 379 of the Indian Penal Code.

Therefore, you are requested to initiate necessary proceeding against the offender in terms of law.
