Sub: To lodge FIR against owner and driver of Swaraj 834 XM (Blue) tractor vide Regd. number WB55B-0389 along with trolley loaded with sand.

Sir,

In producing herewith, 01(one) Swaraj 834 XM (Blue) having Reg. No- WB55B- 0389, engine No. 33.1008/SZK05824 and Chassis No. WZTK25428158662 along with trolley. Today on 28.09.2021 at about 06.35 hrs. acting on source information, I ASI Janardan Kumar of Arsha PS along with (i) C/-146 Maheswar Singh Sardar of Arsha PS (ii) C/- 941 Istaque Ahammed of SAP 7th BN Camp at Arsha PS, Dist-Purulia, left for PS area vide C.C No. 1998/21 Dtd. 27.09.21 and GDE No. 1001 Dt. 27.09.21. After we reached at Beldih village under Arsha PS at 07.05 hrs, we conducted raid on the Bank of River Kansai under Arsha PS and found that 01(one) Tractor along with 01 trolley attached with by a hinge was present at Beldih Ghat on the Bank of River Kansai. Some persons were loading sand in the attached trolley of said tractor. Seeing the Police party, those persons leaving the tractor (loaded with sand in the attached trolley) at Kansai River, fled away. Police rushed to the Tractor and detained the said tractor. Police searched the said tractor and found that the tractor is loaded with sand and also searched surrounding but could not trace out the persons & driver of said offending Tractor. Hence, seized the above noted tractor along with trolley and brought the said tractor to Arsha PS. As there is every reason to believe that the driver and owner of the said tractor with ill motive were transporting sand illegally without any valid document in support of carrying sand and violating the Govt. order they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the owner and driver of tractor vide number WB55B-0389 along with the trolley for investigation.
