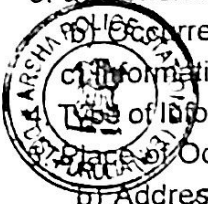

Sir,

In producing here with two arrested accused persons namely (i) Ram Majhi (28yrs) S/O Sufal Majhi of vill- Tanasi and (ii) Jakir Sha (45 yrs) S/O- Lt. Irshad Sha of vill Tumbajhalda, both P.S.-Arsha, Dist-Purulia along with following seized articles.

- 1) One white colour plastic container with approx 27 ltrs. of ID liquor.
(Approx 500 ml taken out from of the above container as sample packed with sealing wax)

I, SI Subal Goswami of Arsha PS do hereby lodge a written complaint against the above noted accused persons to the effect that today i.e 16.09.2021 at about 17.45 hrs. during my Spl. mobile duty at near Aharra more, receive source information over telephone that the above noted accused person have been selling ID liquor at near Arsha Nayamore under Arsha PS. On receiving the reliable source information I communicated with O/C Arsha PS over telephone and as per his instruction myself accompany with (i) C/- 306 Rahul Dev Bhunia (ii) C/45 I Gulsan Kumar and (iii) C/- 840 Sujit Kr. Shaw all of SAP 7th BN Camp at Arsha PS rushed to the spot to work out the information vide Arsha PS C.C. No.1912/21 dtd. 16.09.2021 and GDE No. 594 Dtd. 16.09.2021. Reaching at near Arsha Nayamore we fixed-up the spot and found that selling of Id Liquor was going on there and having seen police all customers managed to escape, but we were able to apprehended the above noted accused persons. On demand of showing papers they failed to produce any valid documents in support of selling ID liquor. So I seized all the implicating articles as noted above under a proper seizure list from their exclusive possession in presence of witnesses and properly sealed and labeled duly signed by the accused persons and witnesses among which Approx 500 ml taken out from the above container as sample packed with sealing wax with label. During interrogation they confessed their guilt so, I arrested them after observing all the formalities issuing memo of arrest as they were selling ID liquor illegally.

I therefore pray that a specific case may kindly be started against the accused persons namely (i) Ram Majhi (28yrs) S/O Sufal Majhi of vill- Tanasi and (ii) Jakir Sha (45 yrs) S/O- Lt. Irshad Sha of vill Tumbajhalda, both P.S.-Arsha, Dist-Purulia under proper section of law.
