Sir,

In producing here with one arrested accused person namely Buddheswar @ Tenu Kalindi (35yrs) S/O Lt. Bharat Kalindi of vill Beldih, P.S.-Arsha Dist-Purulia along with following seized articles.

- 1) Two white colour plastic container with approx 34 ltrs. of ID liquor.  
(Approx 500 ml taken out from of the above container as sample packed with sealing wax)

I, PSI Avijit Mandal of Arsha PS do hereby lodge a written complaint against the above noted accused person to the effect that today i.e 19.09.2021 at about 19.25 hrs. during my anti-crime day mobile duty receive source information over telephone that the above noted accused has been selling ID liquor in his house at Beldih Village. On receiving the reliable source information I communicated with O/C Arsha PS over telephone and as per his instruction I along with C/- 146 Maheswar Singh Sardar and C/- 238 Dipak Bagti both of Arsha PS rushed to the house to work out the information vide Arsha PS C.C. No.1937/21 dtd. 19.09.2021 and GDE No. 696 Dtd. 19.09.2021 Reaching at Beldih village at about 20.35 hrs we fixed-up in the house of above noted accd. person and found that selling of Id Liquor was going on there and having seen police all customers managed to escape, but we were able to apprehended the above noted accused person. On demand of showing papers he failed to produce any valid documents in support of selling ID liquor. So I seized all the implicating articles as noted above under a proper seizure list from his exclusive possession in presence of witnesses and properly sealed and labeled duly signed by the accused person and witnesses among which Approx 500 ml taken out from the above container as sample packed with sealing wax with label. During interrogation he confessed his guilt so, I arrested him after observing all the formalities issuing memo of arrest as he was selling ID liquor illegally.

I therefore pray that a specific case may kindly be started against the accused person namely Buddheswar @ Tenu Kalindi (35yrs) S/O Lt. Bharat Kalindi of vill Beldih, P.S.-Arsha Dist-Purulia under proper section of law.
